

Dear Sirs/Madams,

Concerning your questions addressed to us by 24 May 2012, in relation to public procurement procedure No. IOP/2-2012/G - Procurement of Laboratory and Information and Communications Technology Equipment for Furnishing the Petnica Science Centre, we are sending you the following replies:

Question No. 1:

Section III, Evaluation and Qualification Criteria, Postqualification Requirements:

- Is evidence dated from January 2012 acceptable – valid certificates of the Tax Administration in the Local Self-Government Unit – Public Revenue Office about taxes and contributions paid, or is it necessary to submit certificates with a more recent date since, as specified in the Bidding Documents, the date on pieces of evidence must not be earlier than 60 days before the date of the announcement of the Invitation for Tenders?

Reply to the question No. 1:

- In terms of proving the legal capability, the Bidding Documents, Section III, Evaluation and Qualification Criteria, Item 2 “Postqualification Requirements“, specify that candidates must submit evidence with a date that must not be earlier than 60 days before the date of the announcement of the Invitation for Tenders. Accordingly, pieces of evidence dated January 2012 (certificates of the Tax Administration and of the Local Self-Government Unit – Public Revenue Office about taxes and contributions paid) are not adequate/acceptable evidence.

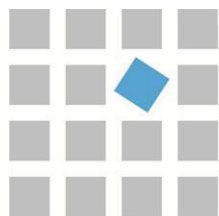
Question No. 2:

- Business capability – requires at least 1 (one) performed contract in the last 5 (five), similar to this contract with a realized (invoiced) minimum value of EUR150,000.00 (Lot. No. 7). Is reference - in the form of a certificate issued by the parent company _____, which is the founder of the company, acceptable?
Can we submit statements by clients of the company _____ and its affiliations as reference?

Reply to the question No. 2:

In order to prove the required business capability, a Bidder is required to prove, by submitting copies of contracts, dispatch notes or statements of earlier clients, that in the past five years the Bidder has performed, successfully and substantially, at least one contract with a minimum value of EUR 150,000.00.

In the case of a joint venture, the Bidder has the possibility to meet the conditions stipulated in the Bidding Documents regarding the business, technical and personnel capabilities cumulatively with the members of the group, in which case it is possible



to submit statements by clients of a group member regarding the proof of the required business capability.

Question No. 3:

Lot 15 Item 3 UPS 10KVA: the Technical Documentation specifies min 1500VA/1350W, are we required to offer UPS of 10 KVA, and if so, what is the minimum power? Spare batteries are also mentioned. What is the required quantity of the spare batteries?

Question No. 4:

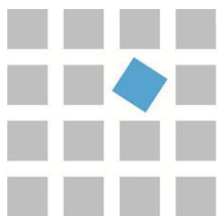
Lot 15 Item 4 Rack, UPS, the technical description is the same as for item 3. Please, provide us with the minimum required properties.

Reply to questions No. 3 and 4:

3	UPS 10,000VA:	On-line with double voltage conversion Real sinus wave output Input voltage 110V to 276V, Automatic bypass Graphics LCD display Smart – microprocessor controlled Management software with network support RS-232 port to PC Spare Batteries 16 x 12V-9Ah
4	Rack UPS 19"	On-line with double voltage conversion Real sinus wave output Input voltage 110V to 276V, Automatic bypass Graphics LCD display min. 1500 VA / 1350 W Management software with network support RS-232 port to PC Spare Batteries

- Simultaneous minimum power for UPS for Item 3 is 10 kVA.
- For each offered/delivered UPS, a Bidder is required to offer/deliver one set of spare batteries. As standard, UPS of 10 kVA is designed with 16 battery units, but we are willing to accept an alternative solution if other requirements from the technical specification are met.

NOTE: If the UPS device has no RS-232 port, and has a USB port, the bid will be accepted if the UPS device is delivered with a USB-to-RS-232 convertor with accompanying cables. In this case, this should be noted in the technical description of the offer.
