Regarding the requests for additional clarification of the tender documents for procurement of capital equipment no IOP/6-2013/G/CEB1-EIB/A, for the period from 8/16/2014. to 8/22/2014, we submit the the following answers:

**Question No. 1:**

(Registered under No. 2403 from 8/18/2014.)

*Dear Sirs, after examining the technical requirement for the subject tender, given the volume, variety and technical complexity of the equipment in each Lot, we find that the term is too short to prepare a bid. Please consider the possibility to extend the deadline for submission of bids.*

**Answer No. 1:**

**Question number 2:**

(Registered under No. 2404 from 8/18/2014.)

*Is it necessary for bidders to submit bank guarantee or is it sufficient to submit promissory note?*

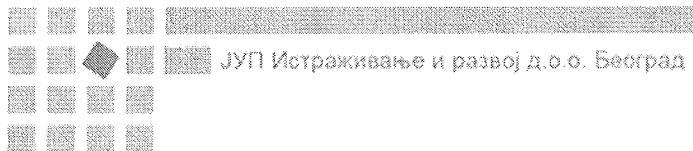
**Answer No. 2:**

*In accordance with the tender documents, it is necessary that the bidder provide a bank guarantee for the bid.*

**Question No. 3:**

(Registered under No. 2405 from 8/18/2014.)

*Is it sufficient for the bidders to submit evidence of registration of bidders in Agency for Business Registers as the proof of fulfillment of the conditions for participation in the tender IOP/6-2013/G/CEB1-EIB/A?*



**Answer No. 3:**

*As the valid evidence of fulfillment of the requirements for participation in the tender you may submit a valid certificate from the register of the Agency for Business Registers.*

**Question No. 4:**

(Registered under No. 2405 from 8/18/2014.)

*Regarding with the following requirements of the tender documents:*

*(b) Business revenue*

*The average annual business revenues in the past three accounting years (2011, 2012 and 2013) must be at least 4.500.000 Euro.*

*Evidence: Registered Financial Statement for the past three accounting years (2011, 2012 and 2013) prepared by the Bidder.*

*This provision applies to all lots and to all members in a joint venture.*

*(c) Business Capability*

*1) At least 3 (three) contracts in the fields related to specific lot(s) of this tender, each with the budget of at least 1.500.000 Euro, successfully and substantially completed in the past three years from the date of this Public Invitation Notice. The similarity is based on physical size, complexity, methods/technology or other characteristics as described in Section VI.*

*Evidence: List of references and Confirmation Letters from Client*

*This provision applies to all lots and to all members in a joint venture.*

*Does the following conditions apply to each bidder who submitted an offer that is part of the lot or are they related to the whole lot (of three total)?*

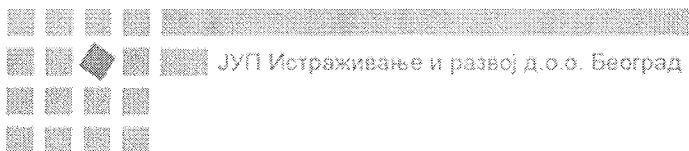
**Answer No. 4:**

*In accordance with the tender documents, the conditions are applicable to each bidder and each member of the consortium.*

**Question No. 5:**

(Registered under No. 2406 from 8/18/2014.)

*In the list included in the tender documents, "Identification of lots", item No TR35042 is mentioned, but there are no technical specifications included in the folder "Lot3 TR tech spec"?*



**Answer No. 5:**

*There has been an accidental exclusion of technical specifications in Lot 3 for item No TR35042. Amended tender documentation was forwarded to all bidders which reported the lack of above mentioned technical specifications.*

**Question No. 6:**

(Registered under No. 2406 from 8/18/2014.)

*In clause ITB 24.1 of the Bidding Data sheet (BDS) the deadline for the submission of the bid is not specified. Please inform about the date.*

**Answer No. 6:**

**Question No. 7:**

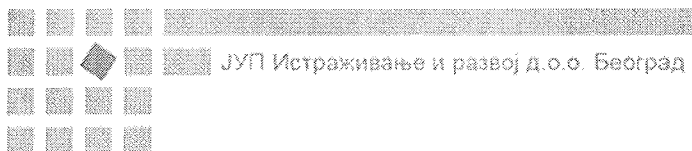
**Question No. 8:**
