Regarding the requests for additional clarification of the tender documents for procurement of capital equipment no IOP/6-2013/G/CEB1-EIB/A, for the period from 9/11/2014. to 9/18/2014, we submit the the following answers:

## Question and Answer No. 19:

(Registered under No. 2641 od 09/11/2014.)

Dear Sir/Madam, in section III, part 2, "Technical Capability" it says:

Service capacity: The Bidder shall provide or ensure provision of all necessary aftersales, services.

Documentary, evidence: Pselaurtian issued by Biddeers describing who is providing warranty – aftersales – maintenance on behalf on manufacturers offered.

1. We assume that "on behalf on manufacturers" means that bidders should submit authorization from manufacturer of equipment for the company in Republic of Serbia, which will provide all "necessary aftersales services" for their equipment. Please confirm.

Answer: Submission of authorization of the manufacturer of the equipment is not obligatory.

2. Also we suppose that it is necessary to submit the approval of such firms for providing "necessary aftersales services" that they will provide all "necessary aftersales services" required by tender documentation. Please confirm.

Answer: According to tender documentation it is not necessary to submit the approval.

#### Question and Answer No. 20:

(Registered under No. 2648 od 09/12/2014)

Dear Sir/Madam, with reference to Tender Project Public Sector Research and Development, your reference no. IOP/6-2013/G/CEB1-EIB/A, we would like to ask you to clarify the following:

#### ITR Clauses 41 and 42.

Under 42.1 (page 25) it states "promptly after notification...". Can you please specify what is considered "promptly" (hours, days, weeks)?

Answer: Mostly it is about days (except in the case of unforeseen circumstances)

Under 42.2 it states "Within twenty-eight (28) hours of receipt of the Agreement...". Is the wording "hours" correct, shouldn't this be "days"? Additionaly how is "receipt" defined? Does this mean via email, via fax, via hardcopy mail, other..? Please clarify.

Answer: Please see Ouestion and Answer No. 16 (3rd group of tonder quations) which was achieved.

Under clauses 41,42 and 43 different wording is used relating tocontract. Under 41.4 "Contract Form" is used, under 43.2 "Contract" is used, and under 42.1 and 42.2 "Agreement" is used. All of these terms are written with a capital but no definition has been provided. Which one of these three items will need to be signed/furnished by the successful bidder?

Answer: Under all three terms it is meant to a form Contract Agreement that must be signed by the successful bidder.

On your last clarifications, you informed that "evidence that the contract was sent on time is the returnee or confirmation of the postal service". Please confirm that by "confirmation of postal service" you mean that a confirmation of sending within 28 hours. (and not necessarily received within 28 hours).

Ańswer: The confirmation of senath'g within 28 nours will be sufficient (not necessarily reception within 28 hours).

On your last clarifications, you stated that "within the bid must be submitted contractual agreement". Can you please clarify? If the Contract Agreement must be submitted with the bid, what other document must be signed, dated and returned by the successful bidder within 28 hours?

<u>Answer:</u> Contract Agreement that is submitted in the offer remains in the offer. After we chose successful bidder we constitute new Contract Agreement based on the same model with the entered data and we re-sends it for the signature.

Certificates to be provided at the time of delivery of goods

The Specifications for some of the items points to manufacturers who are not ISO certified.



## III43007, item 586

Line item suggests a camera. The specification describes a server computer. Please confirm which is required. If it's a camera which is required, please provide correct specifications.

<u>Answer:</u> The error is in the name of the item. ID 586 name now reads: Server Computer. The specification of a server is correct.





## **TR Item 4263**

The specifications are not 100% correct to the current version of this software:

- SMS does not have 3D finite element modeling tools.
- 3. SED2D-WES support is read-only, GENESIS has been replaced by GENCADE, M2D is now CMS-Flow, and WABED is now CMS-Wave. HIVEL2D is no longer supported in SMS 11.2.

Therefore we ask you to kindly remove: "3D finite element modeling tools" and "HIVEL2D" Change: "GENESIS" into "GENCADE", "M2D" into "CMS-Flow" and "WABED" into "CMS-Wave".

<u>Answer:</u> Within specification for Item 4263, we will accept the software of similar characteristics, functionalities and purpose as defined in technical specification schedule. 3D finite modeling tool is not necessary.

The first item is compliant to every technical specification, except for the repeatability (0.002aw instead of 0.001 aw)

The second item is compliant to every technical specification, except for the temperature range (15-50°C instead of 0-50°C)

Therefore our request is:

Please accept a repeatability of 0.002aw.

OR

Please accept a temperature range of 15-50°C.

Answer: We accept repeatability of 0.002aw.

The specifications state "extraction run on 2 samples simultaneously". According to the technical specifications of this item, the dimensions must be 635x 456x 776 mm (WxDxH), which are the dimensions of the same system, but which can run 6 samples simultaneously. Due to this mix of specifications, we would like to ask if the dimensions can be changed into 275x 456x 776 mm (WxDxH)

<u>Answer:</u> Dimensions from technical specification are changed to: 275x456x776 mm (WxDxH). We will accept the device of the same functionalities and purpose and of adequate or superior characteristics with respect to defined in technical specification schedule.

**TR Item 8229** 

One of the technical specifications for this distillation unit is "Pumps for NaOH, H3BO3, H2O". Is it therefore mandatory to have an acid resistant pump? (which will result in a more complex and more expensive item. Seeing the weight specification '16.5 kg', it is probably not meant to ask for the more expensive item.)

<u>Answer:</u> In the technical specification schedule such a request hasn't been defined and, in that sense, pump doesn't have to be acid resistant.

The specifications are written towards an item which is discontinued.

Please change the following specifications, so that we can offer the new model that followed up the discontinued one.

- 1.2.It is equipped with a glass container of 3 l for the neutralization, absorption vessel, and gas pump capacity of 34 l / min.
- 1.3. Apparatuis is designed for modular expansion with condenser or cold trap, and the reaction vessel
- 1.4. Dimensions (LxHxD): 260x450x480 mm
- 1.6. Power consumption: 200 W

### TR Item 8551

The specifications are written on an older model ("Rezolution: min 1280x980 (Megapixel, HD)"). This is for 4:3 monitors. Since all monitors have a 16:9 image ratio, please change this to 1280 x 720. (Request from manufacturer of which this item is written towards)

4nswer: Resolution 1280x 720 is acceptable. We will accept device of similar characteristics.

Please remove the specification "1x hi seed CAN (ISO 11898, 128 signals, read-only)", as this is not part of the apparatus which is written towards in the rest of the specifications.

Answer: "hi seed" changes to "high speed".

**TR Item 5305** 

Is the specification "Synchronization: EtherCAT" really necessary as this specification will make the configuration 1.5 times more expensive. Please clarify.

Answer: The offer should be compliant with the given technical specification.

**TR Item 3477** 

The specifications are written towards a specific refrigerated centrifuge. However, the timer specifications are not correctly written (look in brochures).

Please change "Timer 30 s to 99 min" to "Timer 1 min to 99 min". Furthermore, a centrifuge needs to start up before getting to maximum speed. Therefore a spin time lesser than 1 minute is unlikely to be used.

Answer: Technical specification remains unchanged.

**TR Item 3483** 

Some specifications are a mix between two different configurations. Please change: "d:0" (diffuse illumination/0" viewing angle; specular component included) (compliant with JIS Z 8722; including regular reflectance) Wide-area illumination/0" viewing angle; specular component included)" Into


