The following modifications are made to the Bidding document for procurement of Goods:

Bidding document, Section I Instructions to Bidders, clause 16.3:

„The documentary evidence may be in the form of literature, drawings or data, and shall consist of a detailed item by item description of the essential technical and performance characteristics of the Goods and Related Services, demonstrating substantial responsiveness of the Goods and Related Services to the technical specification, and if applicable, a statement of deviations and exceptions to the provisions of the Section VII, Schedule of Requirements“.

has been modified as follows:

„The documentary evidence can be catalogue of the manufacturer, where it is necessary to clearly mark an item required, and also an item's ID number from appropriate lot“.

Bidding document, Section I Instructions to Bidders, clause 16.4. has been deleted:

“The Bidder shall also furnish a list giving full particulars, including available sources and current prices of spare parts, special tools, etc., necessary for the proper and continuing functioning of the Goods during the period specified in the BDS following commence the use of the goods by the Purchaser”.

Bidding document in Section III, clause 2. Qualification (ITB 36) c) Business capability:

“Maximum 3 (three) contracts of same nature in the fields related to specific lot(s) of this tender, cumulatively exceeding or at least equal to the amount of the total price offered.

This provision applies to all lots and in a case of a joint venture/consortium all parties combined (jointly) should meet the criteria taking into consideration that leading partner must meet not less than fifty (50%) percent of the requirement

Abovementioned contracts shall be successfully and substantially completed in the past 3 (three) years, (2012, 2013 and 2014) from the date of this Public Invitation Notice.

Evidence: Copies of signed contracts (with the list of delivered items which includes quantity and prices), List of references and Confirmation Letters from Client”.

has been modified as follows:

„Maximum 10 (ten) contracts of same nature in the fields related to specific lot(s) of this tender, cumulatively exceeding or at least equal to the amount of the total price offered.

This provision applies to all lots and in a case of a joint venture/consortium all parties combined (jointly) should meet the criteria taking into consideration that leading partner must meet not less than fifty (50%) percent of the requirement

Abovementioned contracts shall be successfully and substantially completed in the past 3 (three) years, (2012, 2013 and 2014) from the date of this Public Invitation Notice.

Evidence: Copies of signed contracts (or invoices, where is the amount of one invoice related to one contract), List of references and Confirmation Letters from Client“.

All other terms and conditions of the Bidding document remain unchanged.

The above amendments are integral part of the Bidding document.
