1	Page 33. Bidding documents, ITB 15.1	Is it necessary to bid for all items in a lot?	Yes, it is necessary to bid for all items in a lot.
.2	Page a 41. Bidding documents	In the section Business capability you state "Maximum 10 (ten) contracts of same nature in the fields related to specific lot(s) of this tender, cumulatively exceeding or at least equal to the amount of the total price offered". Considering that we did not sell 10 individual apparatus of any producer of some items from Lot 218 – Cardiography (e.g. item 1 – id 167228) is it acceptable to submit 10 invoices for all items in the lot (e.g. lot 218 – for items 2, 5, 8)?	The answer is affirmative. Condition from section Business capability says: "Maximum 10 (ten) contracts of same nature in the fields related to specific lot(s) of this tender, cumulatively exceeding or at least equal to the amount of the total price offered." Therefore it is not necessary to submit contracts for those specific items from a lot, but it is enough to have them for items that are of same nature or same field.

7	Do you under Price, Technical and Delivery Schedule imply tables in Excel – lots?	Yes, Price, Technical and Delivery Schedule for every lot is Excel file with tables of technical specifications and the amounts of all items within that lot, data and delivery schedule and fields for inserting the offered prices.
6	Do you under "partija" in Serbian version imply "lot"?	Yes, terms " <i>partija</i> " and "lot" have the same meaning.
5	Is it necessary to submit the Power of Attorney if the signatory of all documents is legal representative - the director?	If the signatory of the requested documents is a legal representative of the bidder, it is not necessary to submit the Power of Attorney.
4	Should there be a total price for all items from the lot together in the Letter of Bid or is the Letter of Bid submitted for every item from the lot separately?	Total offered price for a certain lot, i.e. overall price of all items together in one lot, should be in the Letter of Bid. For one lot you should submit one Letter of Bid.

If the question refers to the evidence on fulfilment of requirements of Business capacity, besides the copies of signed contracts (or in certain cases, copies of invoices, where the amount of one invoice is equal to the amount of one contract), it is necessary to submit the List of References and the Confirmation Letter from a Client.
