





Type of procedure: International open procedure of the public procurement, initiated based on Decision on public procurement procedure number 2697 dated 16.06.2015, according to the Article 7. Paragraph 1. Clause 2) sub-clause (2) Law on public procurement ("Official Gazette of RS", number 124/12 and 14/15), Law on Ratification of the Finance Contract (Public sector research and development) concluded between the Republic of Serbia and the European investment bank ("Official Gazette of RS", number 5/10), Law on Ratification of the Framework Loan Agreement concluded between Council of Europe Development bank and the Republic of Serbia ("Official Gazette of RS", International agreements, number 13/10) and Clause 3.4. of EIB Guide to procurement.

The means for conducting the public procurement are provided by Finance Contract (Public sector research and development) concluded between the Republic of Serbia and the European investment bank, on 04.03.2010, which was ratified by the Law on Ratification of the Finance Contract (Public sector research and development) made between the Republic of Serbia and the European investment bank ("Official Gazette of RS", number 5/10), as well as the Framework Loan Agreement made between Council of Europe Development bank and the Republic of Serbia ("Official Gazette of RS", International agreements, number 13/10).

Public call for the submission of the bids was published in the Official Journal of the European Union (OJEU), on the Portal of Public Procurement Office RS and on the website of the Purchaser on 14.07.2015, with the deadline for the submission of the bids until 14.09.2015, 11:00 am.
