**LOT 231** with the bidder "Max lab d.o.o", Mire Popare 112, 11030 Belgrade, with offered price 4,838.55 € VAT excluded;

Acting according to the suggestion of the Committee given in the Evaluation report, filed under the number 7364 dated 07.12.2015 and the Addendum to the Evaluation report, filed under the number 7571 dated 14.12.2015, it has been decided as in the disposition.

# Legal remedy:

Hereby we state that against this decision, the bidder can file a complaint to the Purchaser within 10 days from the day of Decision reception. The complaint shall be considered as timely if it is received by the purchaser no later than 10 days from the day of Decision reception, regardless of the way of delivery.
