

# Bidding document for procurement of Goods

The following modifications are made to the Bidding document for procurement of Goods:

## -Original text of the Section II. Bid Data Sheet (BDS), ITB 14.8 (b) (i) and (c) (v):

Place of Destination:

Goods should be delivered to the final destination – in accordance with List of goods and Delivery Schedule and List of Related Services given in the Section VII - Schedule of Requirements.

Bid Price should be quoted; DAP+UNLOADED (delivered at users' premises).

Custom duties on import and other related costs are specially declared.

The Purchaser is allowed to accept the offer of goods already imported only in case of having a proof, submitted by the Bidder, of possibility to conduct the revision of the clearance procedure.

#### has been modified as follows:

Place of Destination:

Goods should be delivered to the final destination – in accordance with List of goods and Delivery Schedule and List of Related Services given in the Section VII - Schedule of Requirements.

Bid Price should be quoted: DAP+UNLOADED (delivered at users' premises).

The Purchaser is allowed to accept the offer of goods already imported only in case of having a proof, submitted by the Bidder, of possibility to conduct the revision of the clearance procedure.

- -Letter of Intent of commercial bank on submission of advance payment guarantee in the amount of percentage of advance payment created in accordance with Sub-clause 16.1 of the Special Conditions of Contract, as well as in accordance with provisions of Bank Guarantee for Advance Payment, Section X, Contract Forms
- -Letter of Intent of commercial bank on submission of Performance Guarantee (Security) in the amount of percentage in accordance with Sub-clause 18.1 of the Special Conditions of Contract, as well as in accordance with provisions of Performance Security, Section X, Contract Forms.
- -Declaration issued by Bidders describing who is providing warranty-aftersales-maintenance on behalf of manufacturers of items offered.
- -Documents and Statements defined within Section III. Evaluation and Qualification Criteria
- -All other documents defined by tender documents

#### has been modified as follows:
