GCC 16.1—The method and conditions of payment to be made to the Supplier under this Contract shall be as follows:

i) Advance Payment: Forty (40) percent of the Contract Price shall be paid within forty five (45) days from the day of submission of invoice and bank guarantees: (1) for performance security of the contract and (2) advance payment in equivalent amount valid until the Goods are delivered and in the form provided in the bidding documents or another form acceptable to the Purchaser.

(ii) On receipt of all Goods: Fifty (50) percent of the Contract Price shall be paid on receipt of the Goods, no later than forty five (45) days upon submission of invoice and other relevant documents (i.e. delivery note)

Non-residents should submit the following additional documents:

a) CMR waybill and

b) Single Administrative Document - SAD.

(iii) Implementation of Related Services: Ten (10) percent of the Contract Price shall be paid within forty five (45) days upon submission of Certificate or Minutes of acceptance confirming implementation of all related services stipulated for each item in Technical specifications and Technical requirements, related to proper functioning of goods, such as but not limited to - installation, burn testing, training etc. The Bidder should perform abovementioned services and

(ii) On receipt of all Goods: Fifty (50) percent of the Contract Price shall be paid on receipt of the Goods, no later than forty five (45) days upon submission of invoice and other relevant documents (i.e. delivery note)

Non-residents should submit the following additional documents:

- a) CMR waybill and
- b) Single Administrative Document - SAD.

(iii) Implementation of Related Services: Ten (10) percent of the Contract Price shall be paid within forty five (45) days upon submission of Certificate or Minutes of acceptance confirming implementation of all related services stipulated for each item in Technical specifications and Technical requirements, related to proper functioning of goods, such as but not limited to - installation, burn testing, training etc. The Bidder should perform abovementioned services and inform the Purchaser about results not later than 30 days after delivery of goods.

For the Suppliers which do not request an advance payment, the methods and terms of payment done by the Purchaser according to this Contract are the following:

(i) On receipt of all Goods: Ninety (90) percent of the Contract Price shall be paid on receipt of the Goods, no later than forty five (45) days upon submission of invoice and other relevant documents (i.e. delivery note)

Non-residents should submit the following additional documents:

- b) Single Administrative Document - SAD.

(ii) Implementation of Related Services: Ten (10) percent of the Contract Price shall be paid within forty five (45) days upon submission of Certificate or Minutes of acceptance confirming implementation of all related services stipulated for each item in Technical specifications and Technical requirements, related to proper functioning of goods, such as but not limited to - installation, burn testing, training etc. The Bidder should perform abovementioned services and inform the Purchaser about results not later than 30 days after delivery of goods.
