

In accordance with Article 16. clause 2) Decision on the establishment of a limited liability company for managing of the project Research and Development in Public Sector ("Official gazette of RS", no. 51/2010, 72/2013, 24/2014 and 65/2014), article 7, paragraph 1, clause 2.(2) of the Public procurement law ("Official Gazette of the Republic of Serbia, No. 124/12 and 14/15) Law on Ratification of the Financial Loan Agreement (Public sector research and development) concluded between the Republic of Serbia and the European investment bank ("Official Gazette of RS", number 5/10), article 53. of Rulebook on regulating the public procurement procedure, Decision on public procurement procedure no 6221 dated 12.10.2015. (Amendment to decision on public procurement procedure, number 7507 dated 10.12.2015.), European Investment Bank Guide to procurement, consistently with Evaluation report of public procurement IOP/08-2015/G number 5238 dated 18.03.2016. DECISION ON AMENDMENT to decision on contract award

- 1. Decision on contract award number 6506 dated 07.04.2016, according to the public invitation for bid submission, published in the Official Journal of the European Union (OJEU) on 12.12.2015, and on the website of the Purchaser and Public procurement portal on 14.12.2015, for the Procurement of furniture for the needs of scientific and research organizations, within the Sub-project of the centralized system for stock and purchasing consumables for scientific and research organizations, procurement number IOP/08-2015/G, is amended in clause 1. of the enacting clause and now states:
- "1. Contract is awarded in the international open procedure of the public procurement, number IOP/08-2015/G, the subject of which is: Procurement of furniture for the needs of scientific and research organizations, within the Sub-project of the centralized system for stock and purchasing consumables for scientific and research organizations:
 - For LOT 1 to the bidder "Interglobus" d.o.o. Čačak, Čedomira Vasovića 37, 32000 Čačak, with the value of 184.376,30€ VAT excluded;
 - For LOT 2 to the bidder "Superlab" d.o.o. New Belgrade, Milutina Milankovića 25, 11070 New Belgrade, with the value of 15.523,00€ VAT excluded;
 - For LOT 3 to the bidder "Superlab" d.o.o. New Belgrade, Milutina Milankovića 25, 11070 New Belgrade, with the offered price 7.026,00€ VAT excluded."
 - 2. The other provisions of the Decision on contract award number 6506 dated 07.04.2016. remain unchanged.
 - 3. This decision shall be published on the website of the Purchaser within three days from the day of its delivering.

RATIONALE

Purchaser has, in the Decision on contract award number 6506 dated 07.04.2015, in the international open procedure of the public procurement, number IOP/08-2015/G, the subject of which is: Procurement of furniture for the needs of scientific and research organizations, within the Sub-project of the centralized system for stock and purchasing consumables for scientific and research organizations, awarded contracts to:

- For LOT 1 to the bidder "Interglobus" d.o.o. Čačak, Čedomira Vasovića 37, 32000 Čačak, with offered price 188.460,33 € VAT excluded;
- For LOT 2 to the bidder "Superlab" d.o.o. New Belgrade, Milutina Milankovića 25, 11070 New Belgrade, with offered price 16.473,00 € VAT excluded;
- For LOT 3 to the bidder "Superlab" d.o.o. New Belgrade, Milutina Milankovića 25, 11070 New Belgrade, with offered price 7.026,00 € VAT excluded."

On 07.04.2016 the Department for technical preparation of procurements (letter number 94/2016 dated 07.04.2016) informed the Purchaser that there have been a termination of needs of the project managers – end users for the certain amount of goods, which are included in the procurement IOP/08-2015/G.

Namely, the manager of the project ON171017 as the end user, has expressed the need for goods which are the subject of this procurement, by inserting them in the recording system until 16.11.2014. which was updated through a questionnaire conducted in the period from 10th November to 23rd November 2015.

However, the project manager – end user addressed the Purchaser with the request to be enabled to make changes in the order, i.e. to decrease the amount of goods for which the need was expressed and which are the subject of the procurement, due to the lack of the available means on the project ON171017.

Based on the mentioned request, the Department for the technical preparation of procurements determined that the goods for which the project manager – end user sent a request to be enabled to change the order, i.e. to decrease the amounts, are included in the procurement IOP/08-2015/G within Lot 1 and Lot 2, for which the Decision on contract award was delivered, number 6506 dated 07.04.2016.

Bidding document in Section I Instructions to bidders, in clause 39. sub clause 39.1 defines that at the time of contract award, the Purchaser pertains his right to increase or decrease the amount of goods and the following services which were originally determined in Section VII Schedule of Requests, under the condition that by doing so the percentage, mentioned in Section II Bidder information sheet, is not increased, and without any changes in unit prices or other conditions of the bid and bidding document. In Section II Bidder information sheet, ITB 39.1 F — Award of contract, defines that The Purchaser reserves the right to vary quantities specified in the bid by +/- 100 % at the time of contracting and that the total value of the supplies may not, as a result of the variation, rise or fall by more than 25 % of the original financial offer in the bid, and the offered amount has to be in line with the estimated value from Purchaser's Financial Plan as well as that the unit prices quoted in the bid shall be used.

Pursuant to everything abovementioned it has been decided as in the enacting clause.

Legal remedy:

Hereby we state that against this decision, the bidder can file a complaint to the Purchaser within 10 days from the day of publishing the Decision on the website of the Purchaser.
