The Committee noted that there are no untimely bids.

After the conducted bid opening procedure, the Committee started evaluation of the submitted bids, which are the subject of this report.



Evaluation was done in accordance with the relevant provisions of the Bidding Document – Section I – Instructions to bidders E. Evaluation and comparison of bids, as well as the Section III - Evaluation and Qualification Criteria.

Section I - Instructions to bidders E. Evaluation and comparison of bids, clause 29. Determination of Responsiveness, sub-clause (29.2) defines that a substantially responsive - adequate bid is one that meets the requirements of the Bidding Documents without material deviation, reservation, or omission. Sub-clause (29.4) defines that if a bid is not substantially responsive to the requirements of Bidding Documents or financially does not comply (is not acceptable) with the Purchaser's Procurement Plan, it shall be rejected by the Purchaser, and such bid cannot be made responsive through the corrections of the material deviation, reservation, or omission.

During the evaluation of the bids, the Committee noted as follows:

During the evaluation of the bid, Committee noted that the bidder in accordance with the Section III – Evaluation and Qualification criteria, clause 2.3 Professional capacity of the bidder, sub-clause 2.3.1 Professional capacity, among other things, did not submit Form EXP Experience. Bidding Document foresees that the bidder proves the fulfilment of the conditions for Professional capacity by submitting the following evidence:

Considering that the estimated value for Lot 001 is 122,000.00 €, the Committee notes that the offered price is lower than the estimated value, i.e. that it is financially acceptable – acceptable bid.

According to the aforementioned, the Committee notes that the bid by the bidder Globe Corporation bv is substantially not responsive – inadequate and financially acceptable – acceptable bid.

**LOT 002:**

**1) Bid by the bidder Superlab d.o.o. Beograd (Milutina Milankovića 25, 11000 Belgrade), bid number 3392 dated 29.02.2016.**

Committee notes that the bid has the following deficiency:

- Offered technical specification does not fulfil the requests from the Bidding Document.

Offered price is: 5,355.80 € VAT excluded.

Considering that the estimated value for Lot 002 is 17,340.00 €, Committee notes that the offered price is lower than the estimated value, i.e. that it is financially acceptable - acceptable bid.

According to the aforementioned, the Committee notes that the bid by the bidder Superlab d.o.o. Beograd is substantially not responsive - inadequate and financially acceptable - acceptable bid.

**2) Bid by the bidder Društvo za trgovinu i usluge ProMedia d.o.o. Kikinda (Kralja Petra I 114, 23300 Kikinda), bid number 3416 dated 29.02.2016.**

Committee evaluated that the bid fulfils the requests from the Bidding Document, and it notes that the bid is substantially responsive - adequate bid.

Offered price is: 5,358.40 € VAT excluded.

Considering that the estimated value for Lot 002 is 17,340.00 €, Committee notes that the offered price is lower than the estimated value, i.e. that it is financially acceptable - acceptable bid.

According to the aforementioned, the Committee notes that the bid by the bidder Društvo za trgovinu i usluge ProMedia d.o.o. Kikinda is substantially responsive – adequate and financially acceptable - acceptable bid.

**LOT 003:**

**1) Bid by the bidder Canberra Packard Central Europe GmbH (Wienersiedlung 6, A 2432 Schwadorf Austria), bid number 2337 dated 17.02.2016.**

Committee evaluated that the bid has the following deficiency – at the request of the Purchaser to extend the bid validity period until 11.10.2016., bidder did not extend the bid validity period, and therefore the bid is substantially not responsive – inadequate bid.

Offered price is: 44,982.00 € VAT excluded.

Considering that the estimated value for Lot 003 is 60,000.00 €, Committee notes that the offered price is lower than the estimated value, i.e. that it is financially acceptable - acceptable bid.

According to the aforementioned, the Committee notes that the bid by the bidder Canberria Packard Central Europe GmbH is substantially not responsive – inadequate bid and financially acceptable - acceptable bid.

**2) Bid by the bidder Engel d.o.o. za proizvodnju, trgovinu i usluge Novi Sad (Novaka Radonjica 59, 21000 Novi Sad), bid number 3386 dated 29.02.2016.**

During the evaluation of the bid, Committee noted that the bidder, in accordance with the Section III – Evaluation and Qualification criteria, clause 2.3 Professional capacity of the bidder, sub-clause 2.3.1 Professional capacity, in the Form EXP Experience listed, among other things, the contract concluded with the Directorate of Measures and Precious Metals in the value of delivered goods of 338,900.00 euros in the period from 30.05.2012. until 07.06.2013 (contract number 393-1/0-01-78/12 dated 30.05.2012.). Attached to the form he also submitted the following documents:

- Contract on the public procurement concluded with the Directorate of Measures and Precious Metals, number 393-1/0-01-78/12 dated 30.05.2012. where the total contracted price including VAT is 44,510,692.20 dinars,
- Bid dated 17.04.2012. with the total offered price VAT excluded of 338,900.00 euros and
- Confirmation of the Purchaser – user number 508/16 dated 23.02.2016. in which the purchaser confirms that the contract obligations have been executed in the amount of 383,900.00 euros.

Considering that the estimated value for Lot 003 is 60,000.00 €, Committee notes that the offered price is lower than the estimated value, i.e. that it is financially acceptable - acceptable bid.

According to the aforementioned, the Committee notes that the bid by the bidder Engel d.o.o. za proizvodnju, trgovinu i usluge Novi Sad is substantially responsive – adequate and financially acceptable - acceptable bid.

**3) Bid by the group of bidders Pan Computers d.o.o. (Puškinova 11, 21000 Novi Sad) i Ibis Instruments d.o.o. (Tošin bunar 272, 11070 Beograd), bid number 3408 dated 29.02.2016.**

Committee evaluated that the bid fulfils the requests from the Bidding Document, and it notes that the bid is substantially responsive - adequate bid.

Offered price is: 68,000.00 € VAT excluded.

Considering that the estimated value for Lot 003 is 60,000.00 €, Committee notes that the offered price is higher than the estimated value, i.e. that the bid is financially unacceptable - unacceptable bid.

According to the aforementioned, Committee notes that the bid by the group of bidders Pan Computers d.o.o. and Ibis Instruments d.o.o. is substantially responsive - adequate and financially unacceptable - unacceptable bid.

**LOT 004:**

**1) Bid by the group of bidders Pan Computers d.o.o. (Puškinova 11, 21000 Novi Sad) and Ibis Instruments d.o.o. (Tošin bunar 272, 11070 Belgrade), bid number 3409 dated 29.02.2016.**

Committee evaluated that the bid has the following deficiency – at the request of the Purchaser to extend the bid validity period until 11.10.2016., bidder did not extend the bid validity period, and therefore the bid is substantially not responsive – inadequate bid.

Offered price is: 4,800.00 € VAT excluded.

Considering that the estimated value for Lot 004 is 12,000.00 €, Committee notes that the offered price is lower than the estimated value, i.e. that it is financially acceptable - acceptable bid.

According to the aforementioned, Committee notes that the bid by the group of bidders Pan Computers d.o.o. and Ibis Instruments d.o.o. is substantially not responsive – inadequate bid and financially acceptable - acceptable bid.

**LOT 005:**

**1) Bid by the bidder Globe Corporation bv (Galvaniweg 4, 6101 XH ECHT, The Netherlands), bid number 3316 dated 26.02.2016.**

During the evaluation of the bid, Committee noted that the bidder in accordance with the Section III – Evaluation and Qualification criteria, clause 2.3 Professional capacity of the bidder, sub-clause 2.3.1 Professional capacity, among other things, did not submit Form EXP

Experience. Bidding Document foresees that the bidder proves the fulfilment of the conditions for Professional capacity by submitting the following evidence:

- Copies of signed contracts (or exceptionally, Copies of Invoices in question, and in that case the amount of the single invoice corresponds to a single contract),
- List of references and
- Confirmation Letter from Client.

Having in mind that the requested professional capacity is undoubtedly proven by the bidder by submitting the other documents, the non-submission of Form EXP Experience is not considered to be a deficiency.

Committee notes that the bid has the following deficiencies:

- In accordance with the Section X Contract forms the bidder submitted Model contract on the procurement of goods unsigned and unverified by a stamp;
- offered technical specification does not fulfil the requests from the Bidding Document.

Offered price is: 49,314.69 € VAT excluded.

Considering that the estimated value for Lot 005 is 67,850.00 €, Committee notes that the offered price is lower than the estimated value, i.e. that it is financially acceptable - acceptable bid.

According to the aforementioned, the Committee notes that the bid by the bidder Globe Corporation bv, is substantially not responsive - inadequate and financially acceptable - acceptable bid.

**2) Bid by the bidder Superlab d.o.o. Beograd (Milutina Milankovića 25, 11000 Beograd), bid number 3393 dated 29.02.2016.**

Committee notes that the bid has the following deficiency:

- offered technical specification does not fulfil the requests from the Bidding Document.

Offered price is: 63,345.00 € VAT excluded.

Considering that the estimated value for Lot 005 is 67,850.00 €, Committee notes that the offered price is lower than the estimated value, i.e. that it is financially acceptable - acceptable bid.

According to the aforementioned, the Committee notes that the bid by the bidder Superlab d.o.o. Beograd is substantially not responsive - inadequate and financially acceptable - acceptable bid.

**3) Bid by the bidder Alfa Genetics d.o.o. Beograd (Račkoga 5, 11080 Beograd), bid number 3407 dated 29.02.2016.**

Committee evaluated that the bid fulfils the requests from the Bidding Document, and it notes that the bid is substantially responsive - adequate bid.

Offered price is: 66,849.00 € VAT excluded.

Considering that the estimated value for Lot 005 is 67,850.00 €, Committee notes that the offered price is lower than the estimated value, i.e. that it is financially acceptable - acceptable bid.

According to the aforementioned, Committee notes that the bid by the bidder Alfa Genetics d.o.o. Beograd is substantially responsive – adequate and financially acceptable - acceptable bid.

**LOT 006:**

**1) Bid by the bidder DSP Chromatography d.o.o. Beograd (Milutina Milanović  
120g, 11070 Belgrade), bid number 3385 dated 29.02.2016.**

During the evaluation, the Committee noted that in Annex I – Technical specification the offered items are defined by clauses 27. – Thermostated column compartment and 28. – Temperature range: 20 - 100°C, while in the catalogue it is impossible to determine whether the certificate (brochure) on the thermostating of the column is also to be delivered.

Having in mind that in Section I – Instructions to bidders, clause 16. Documents Establishing the Eligibility and Conformity of the Goods and Related Services, in order to determine the conformity of goods and the related services with the bidding document, it is foreseen for the bidder to submit, as a part of his bid, evidence that the goods are in conformity with technical specification in accordance with the Section VII – Schedule of requirements, clause 2. Technical specification (Annex I), it is foreseen that the bidder, who participates in the procedure of the procurement, shall submit the filled form Annex I – Technical specification and that he is obliged to submit, with it, the catalogue in which he has to clearly mark the product (type/model) with a highlighter, with all its additional parts, which is being offered and also he has to mark the lot and the item within the lot to which the bid refers. On 16.05.2016 the Committee sent to the bidder a request for further clarification (number 7510 dated 16.05.2016.), in which it is requested for the bidder to submit the clarification of whether within the equipment which he offers there is a certificate (brochure) on the thermostating of the column.

On 17.05.2016. the bidder submitted the clarification of the bid (number 7518 dated 17.05.2016.) in which he confirms that the bid for LC MS/MS system includes the thermostated column compartment Agilent Technologies 1290 series, catalogue number G1316C which has the option of controlling the temperature column in range from 10°C below the room temperature to 100°C as is listed in the technical offer and fully fulfils the set technical request for the control of temperature in the range from 20 - 100°C. Also, the bidder submitted attached the specification of the manufacturer for the offered module.

Offered price is: 187,420.90 € VAT excluded.

Considering that the estimated value for Lot 006 is 190,000.00 €, Committee notes that the offered price is lower than the estimated value, i.e. that it is financially acceptable - acceptable bid.

According to the aforementioned, the Committee notes that the bid by the bidder DSP Chromatography d.o.o. Beograd substantially responsive – adequate and financially acceptable - acceptable bid.

**2) Bid by the group of bidders Shimadzu d.o.o. Beograd (Goce Delčeva 46/I, 11070 New Belgrade) and Ogranak Shimadzu Branch Beograd (Goce Delčeva 46/I, 11070 New Belgrade), bid number 3357 dated 29.02.2016.**

Committee notes that the bid has the following deficiencies:

- offered technical specification does not fulfil the requests from the Bidding Document.
- Instrument of financial security for Bid Security has shorter validity period than the requested one in the Bidding Document.

Offered price is: 139,000.00 € VAT excluded.

Considering that the estimated value for Lot 006 is 190,000.00 €, Committee notes that the offered price is lower than the estimated value, i.e. that it is financially acceptable - acceptable bid.

According to the aforementioned, Committee notes that the bid by the group of bidders Shimadzu d.o.o. Beograd and Ogranak Shimadzu Branch Beograd is substantially not responsive - inadequate and financially acceptable - acceptable bid.

**3) Bid by the bidder Analysis d.o.o. (Gandijeva 76a, 11070 New Belgrade), bid number 3381 dated 29.02.2016.**

Committee evaluated that the bid fulfils the requests from the Bidding Document, and it notes that the bid is substantially responsive - adequate bid.

Offered price is: 152,650.00 € VAT excluded.

Considering that the estimated value for Lot 006 is 190,000.00 €, Committee notes that the offered price is lower than the estimated value, i.e. that it is financially acceptable - acceptable bid.

According to the aforementioned, the Committee notes that the bid by the bidder Analysis d.o.o. is substantially responsive – adequate and financially acceptable - acceptable bid.

**LOT 007:**

**1) Bid by the bidder Globe Corporation by, Galvaniweg 4, 6101 XH ECHT, The Netherlands, bid number 3315 dated 26.02.2016.**

During the evaluation of the bid, Committee has determined that Annex I – Technical specification does not state the item "Quartz Crystal Thickness Monitor(s)" for measuring the

thickness of the deposited layer, while it is mentioned in the following documentation (catalogue), in part related to the software control and in part which states the device for cooling the source and thickness meter

Section I – Instructions to bidders, clause 16. Documents Establishing the Eligibility and Conformity of the Goods and Related Services, in order to determine the conformity of the goods and the following services with the tender document, foresees that the bidder should submit, as the part of his bid, evidence that the goods are in conformity with the technical specification, in accordance with the Section VII - Schedule of Requirements. In Section VII - Schedule of Requirements, clause 2. Technical Specification (Annex I), the bidder who participates in the procurement procedure submits the filled form Annex I – Technical Specification and he is obliged to submit the catalogue, with the bid, in which he has to clearly mark, with the marker, the product (type/model) with all additional parts, which is being offered and also the lot and the item within the lot to which the bid refers have to be marked. Having this in mind, the Committee sent to the bidder a request for clarification, on 16.05.2016, (number 7513 dated 16.05.2016.) in which it requires the bidder to submit the clarification of whether the equipment he offers includes the "Quartz Crystal Thickness Monitor(s)".

On 23.05.2016. the Bidder submitted the clarification of the bid (number 7941 dated 23.05.2016.) in which he confirms that "Quartz Crystal Thickness Monitor(s)" is included in the offered equipment.

According to the aforementioned, Committee evaluated that the bid fulfils the requests from the Bidding Document, and it notes that the bid is substantially responsive - adequate bid.

Also, during the evaluation of the bid, Committee noted that the bidder in accordance with the Section III – Evaluation and Qualification criteria, clause 2.3 Professional capacity of the bidder, sub-clause 2.3.1 Professional capacity, among other things, did not submit Form EXP Experience.

Bidding Document foresees that the bidder proves the fulfilment of the conditions for Professional capacity by submitting the following evidence:

- Copies of signed contracts (or exceptionally, Copies of Invoices in question, and in that case the amount of the single invoice corresponds to a single contract),
- List of references and
- Confirmation Letter from Client.

Having in mind that the requested professional capacity is undoubtedly proven by the bidder by submitting the other documents, the non-submission of Form EXP Experience is not considered to be a deficiency.

Committee notes that the bid has the following deficiency:

- In accordance with Section X Contract forms bidder submitted the Model contract on the procurement of goods which is not signed and not verified by a stamp;

Offered price is: 216,383.17 € VAT excluded



Considering that the estimated value for Lot 007 is 134,000.00 €, Committee notes that the offered price is higher than the estimated value, i.e. that the bid is financially unacceptable - unacceptable bid.

According to the aforementioned, the Committee notes that the bid by the bidder Globe Corporation bv, is substantially not responsive - inadequate and financially unacceptable - unacceptable bid.

**2) Bid by the bidder Kvark d.o.o. Kragujevac (Karadordeva 33, 34 000 Kragujevac), bid number 3405 dated 29.02.2016.**

Committee notes that the bid has the following deficiency:

- offered technical specification does not fulfil the requests from the Bidding Document.

Offered price is: 129,680.00 € VAT excluded.

Considering that the estimated value for Lot 007 is 134,000.00 €, Committee notes that the offered price is lower than the estimated value, i.e. that it is financially acceptable - acceptable bid.

According to the aforementioned, the Committee notes that the bid by the bidder Kvark d.o.o. Kragujevac is substantially not responsive - inadequate and financially acceptable - acceptable bid.

**LOT 008:**

**1) Bid by the bidder Proanalitica d.o.o. (Bulevar umetnosti 27, 11070 New Belgrade), bid number 3366 dated 29.02.2016.**

Committee evaluated that the bid fulfils the requests from the Bidding Document, and it notes that the bid is substantially responsive - adequate bid.

Offered price is: 155,500.00 € VAT excluded.

Considering that the estimated value for Lot 008 is 155,600.00 €, Committee notes that the offered price is lower than the estimated value, i.e. that it is financially acceptable - acceptable bid.

According to the aforementioned, the Committee notes that the bid by the bidder Proanalitica d.o.o. is substantially responsive – adequate and financially acceptable - acceptable bid.

**2) Bid by the bidder Analysis d.o.o. Beograd (Gandijeva 76a, 11070 New Belgrade), bid number 3380 dated 29.02.2016.**

Committee evaluated that the bid fulfils the requests from the Bidding Document, and it notes that the bid is substantially responsive - adequate bid.

Offered price is: 537,150.00 € VAT excluded.

Considering that the estimated value for Lot 010 is 126,000.00 €, Committee notes that the offered price is lower than the estimated value, i.e. that it is financially acceptable - acceptable bid.

According to the aforementioned, Committee notes that the bid by the group of bidders Tehnooptika Smolnikar and Mikronik d.o.o. is substantially not responsive - inadequate and financially acceptable - acceptable bid.

**2) Bid by the bidder Galen-Fokus d.o.o. Beograd (Hadži Milentijeva 34, 11000 Beograd), bid number 3363 dated 29.02.2016.**

Committee notes that the bid has the following deficiency:

- In accordance with the Section X Contract Forms, the bidder did not submit the Model contract on the procurement of goods, signed and verified by a stamp;

Offered price is: 99,900.00 € VAT excluded.

Considering that the estimated value for Lot 010 is 126,000.00 €, Committee notes that the offered price is lower than the estimated value, i.e. that it is financially acceptable - acceptable bid.

According to the aforementioned, the Committee notes that the bid by the bidder Galen-Fokus d.o.o. Beograd is substantially not responsive - inadequate and financially acceptable - acceptable bid.

According to the aforementioned, the Committee notes that the bid by the bidder Kvark d.o.o. Kragujevac is substantially responsive – adequate and financially acceptable - acceptable bid.

According to the aforementioned, Committee notes that the bid by the group of bidders Tehnooptika Smolnikar and Mikronik d.o.o. is substantially not responsive - inadequate and financially acceptable - acceptable bid.

**LOT 013:**

**1) Bid by the bidder DSP Chromatography d.o.o. Beograd (Milušina Milankovića 120g, 11070 Novi Beograd), bid number 3383 dated 29.02.2016.**

Committee notes that the bid has the following deficiency:

- offered technical specification does not fulfil the requests from the Bidding Document.

Offered price is: 92,648.30 € VAT excluded.

Considering that the estimated value for Lot 013 is 105,625.00 €, Committee notes that the offered price is lower than the estimated value, i.e. that it is financially acceptable - acceptable bid.

According to the aforementioned, the Committee notes that the bid by the bidder DSP Chromatography d.o.o. Beograd is substantially not responsive - inadequate and financially acceptable - acceptable bid.

**2) Bid by the group of bidders Shimadzu d.o.o. Beograd (Goce Delčeva 46/I 11070 New Belgrade) and Ogranak Shimadzu Branch Beograd (Goce Delčeva 46/I 11070 New Belgrade), bid number 3359 dated 29.02.2016.**

Committee notes that the bid has the following deficiencies:

- offered technical specification does not fulfil the requests from the Bidding Document.
- Instrument of financial security for Bid Security has shorter validity period than the requested one in the Bidding Document.

Offered price is: 77,000.00 € VAT excluded.

Considering that the estimated value for Lot 013 is 105,625.00 €, Committee notes that the offered price is lower than the estimated value, i.e. that it is financially acceptable - acceptable bid.

According to the aforementioned, Committee notes that the bid by the group of bidders Shimadzu d.o.o. Beograd and Ogranak Shimadzu Branch Beograd is substantially not responsive - inadequate and financially acceptable - acceptable bid.

#### **LOT 014:**

##### **1) Bid by the bidder Ing. Prager Elektronik Handels GmbH (2120 Wolkersdorf, Traunstrasse 21), bid number 2422 dated 17.02.2016.**

During the evaluation, the Committee determined that in the Letter of Bid under (e) the total price of our Bid, excluding any discounts offered in item (f), the amount of 293,765.00 euros is stated, while in the Price schedule form for goods and related services (Annex II) the amount of 7,200.00 euros is stated.

Having in mind that, Section IV – Bidding forms, table of the forms, under 1. and 6. foresees that the bidder who participates in the public procurement, should fill in the Letter of Bid and Price schedule form for goods and related services (Annex II) where, among other things, he should insert the total price of his bid excluding VAT, determined in the Republic of Serbia, the Committee, on 16.05.2016., sent to the bidder a request for further clarification (number 7512 dated 16.05.2016.) since there are discrepancies in respect of the abovementioned amounts in Letter of Bid and Price schedule form for goods and related services (Annex II), to submit the clarification of whether the amount of 293,765.00 euros, which the bidder stated in the Letter of Bid, is his offered price excluding VAT, determined in the Republic of Serbia.

Also, the Committee evaluated that he bid has the following deficiencies:

- In accordance with the Section IV Bidding forms, Form EXP Experience is not submitted, contracts nor the confirmation letter form a client;
- In accordance with the Section X Contract forms the bidder submitted Model contract on the procurement of goods not signed and not verified by a stamp;

According to the aforementioned, the Committee notes that the bid by the bidder Ing. Prager Elektronik Handels GmbH is substantially not responsive - inadequate and financially unacceptable - unacceptable bid.

**2) Bid by the bidder TSI GmbH (Neukoellner str. 4, Achen Germany), bid number 3307 dated 26.02.2016.**

Committee evaluated that the bid fulfils the requests from the Bidding Document, and it notes that the bid is substantially responsive - adequate bid.

Offered price is: 209,935.00 € VAT excluded.

Considering that the estimated value for Lot 014 is 211,500.00 €, Committee notes that the offered price is lower than the estimated value, i.e. that it is financially acceptable - acceptable bid.

According to the aforementioned, Committee notes that the bid by the bidder TSI GmbH is substantially responsive – adequate and financially acceptable - acceptable bid.

**LOT 015:**

**1) Bid by the bidder Micom TM International d.o.o. (Bulevar Vojvode Mišića 39a, 11000 Beograd), bid number 3420 dated 29.02.2016.**

Committee notes that the bid has the following deficiency:

- In accordance with the Section III Evaluation and Qualification criteria, under 2.3 Professional capacity of bidder, it is requested as evidence for the bidder to submit at most two contracts whose value is over or at least equal to the value of the bid, however the bidder submitted three contracts where the value of any two contracts cumulatively is below the value of the bid.

- Instrument of financial security for Bid Security is not submitted;

Offered price is: 169,000.00 € VAT excluded.

Considering that the estimated value for Lot 015 is 100,000.00 €, Committee notes that the offered price is higher than the estimated value, i.e. that the bid is financially unacceptable - unacceptable bid.

According to the aforementioned, the Committee notes that the bid by the bidder Micom TM International d.o.o. is substantially not responsive - inadequate and financially unacceptable – unacceptable bid.

**LOT 016:**

**1) Bid by the group of bidders Shimadzu d.o.o. Beograd (Goce Delčeva 46/1 11070 Novi Beograd) and Ogranak Shimadzu Branch Beograd (Goce Delčeva 46/1 11070 Novi Beograd), bid number 3360 dated 29.02.2016.**

Committee notes that the bid has the following deficiency:

- offered technical specification does not fulfil the requests from the Bidding Document.

- Instrument of financial security for Bid Security has shorter validity period than the requested one in the Bidding Document.

Offered price is: 147,000.00 € VAT excluded.

Considering that the estimated value for Lot 016 is 220,000.00 €, Committee notes that the offered price is lower than the estimated value, i.e. that it is financially acceptable - acceptable bid.

According to the aforementioned, Committee notes that the bid by the group of bidders Shimadzu d.o.o. Beograd and Ogranak Shimadzu Branch Beograd is substantially not responsive - inadequate and financially acceptable - acceptable bid.

**2) Bid by the bidder Donau Lab d.o.o. Beograd (Karadorđeva 15/2, 11080 Belgrade), bid number 3414 dated 29.02.2016.**

Committee evaluated that the bid fulfils the requests from the Bidding Document, and it notes that the bid is substantially responsive - adequate bid.

Offered price is: 212,297.00 € VAT excluded.

Considering that the estimated value for Lot 016 is 220,000.00 €, Committee notes that the offered price is lower than the estimated value, i.e. that it is financially acceptable - acceptable bid.

According to the aforementioned, the Committee notes that the bid by the bidder Donau Lab d.o.o. Beograd is substantially responsive – adequate and financially acceptable - acceptable bid.

**3) Bid by the bidder Krug International LTD. Malta Ogranak Krug Beograd (Deset Avjatićara 2A, 11050 Beograd), bid number 3413 dated 29.02.2016.**

Committee notes that the bid has the following deficiency:

- offered technical specification does not fulfil the requests from the Bidding Document.

Offered price is: 194,920.00 € VAT excluded.

Considering that the estimated value for Lot 016 is 220,000.00 €, Committee notes that the offered price is lower than the estimated value, i.e. that it is financially acceptable - acceptable bid.

According to the aforementioned, the Committee notes that the bid by the bidder Krug International LTD. Malta Ogranak Krug Beograd is substantially not responsive - inadequate and financially acceptable - acceptable bid.

**4) Bid by the bidder ROFA - Laboratory & Process Analyzers (Mag. Matthias Fiedler e.U. Austria), bid number 3415 dated 29.02.2016.**



Committee evaluated that the bid fulfils the requests from the Bidding Document, and it notes that the bid is substantially responsive - adequate bid.

Offered price is: 208,900.00 € VAT excluded.

Considering that the estimated value for Lot 016 is 220,000.00 €, Committee notes that the offered price is lower than the estimated value, i.e. that it is financially acceptable - acceptable bid.

According to the aforementioned, the Committee notes that the bid by the bidder ROFA - Laboratory & Process Analyzers is substantially responsive – adequate and financially acceptable - acceptable bid.

#### **LOT 017:**

- 1) **Bid by the group of bidders Pan Computers d.o.o. (Puškinova 11, 21000 Novi Sad) and Ibis Instruments d.o.o. (Tošin bunar 272, 11070 Beograd,) bid number 3410 dated 29.02.2016.**

Committee evaluated that the bid fulfils the requests from the Bidding Document, and it notes that the bid is substantially responsive - adequate bid.

Offered price is: 176,000.00 € VAT excluded.

Considering that the estimated value for Lot 017 is 64,330.00 €, Committee notes that the offered price is higher than the estimated value, i.e. that the bid is financially unacceptable - unacceptable bid.

According to the aforementioned, Committee notes that the bid by the group of bidders Pan Computers d.o.o. and Ibis Instruments d.o.o. is substantially responsive - adequate and financially unacceptable - unacceptable bid.

- 2) **Bid by the bidder Globe Corporation by (Galvaniweg 4, 6101 XH ECHT, The Netherlands), bid number 3314 dated 26.02.2016.**

**3) Bid by the bidder Kefo d.o.o. Beograd (Bačka 1U, 11080 Beograd), bid number 3350 dated 29.02.2016.**

Committee evaluated that the bid fulfils the requests from the Bidding Document, and it notes that the bid is substantially responsive - adequate bid.

Offered price is: 64,300.00 € VAT excluded.

Considering that the estimated value for Lot 017 is 64,330.00 €, Committee notes that the offered price is lower than the estimated value, i.e. that it is financially acceptable - acceptable bid.

According to the aforementioned, the Committee notes that the bid by the bidder Kefo d.o.o. Beograd is substantially responsive – adequate and financially acceptable - acceptable bid.

**LOT 018:**

**1) Bid by the bidder DSP Chromatography d.o.o. Beograd (Milutina Milanковиќа 120g, 11070 Novi Beograd), bid number 3382 dated 29.02.2016.**

Committee evaluated that the bid fulfils the requests from the Bidding Document, and it notes that the bid is substantially responsive - adequate bid.

Offered price is: 38,144.36 € VAT excluded.

Considering that the estimated value for Lot 018 is 40,300.00 €, Committee notes that the offered price is lower than the estimated value, i.e. that it is financially acceptable - acceptable bid.

According to the aforementioned, the Committee notes that the bid by the bidder DSP Chromatography d.o.o. Beograd is substantially responsive – adequate and financially acceptable - acceptable bid.

**LOT 019:**

- 1) Bid by the bidder Oroboros Instruments Corporation (Schoepfstrasse 18, 6020 Innsbruck Austria), bid number 3051 dated 24.02.2016. and Amendment to the bid, number 3168 dated 25.02.2016.**

Offered price is: 38,968.00 € VAT excluded.

Considering that the estimated value for Lot 019 is 34,893.6 €, Committee notes that the offered price is higher than the estimated value, i.e. that the bid is financially unacceptable - unacceptable bid.

According to the aforementioned, the Committee notes that the bid by the bidder Oroboros Instruments Corporation is substantially responsive – adequate and financially unacceptable - unacceptable bid.

Considering that the estimated value for Lot 020 is 95,414.76 €, Committee notes that the offered price is higher than the estimated value, i.e. that the bid is financially unacceptable - unacceptable bid.

According to the aforementioned, Committee notes that the bid by the bidder Superlab d.o.o. Beograd is substantially responsive - adequate and financially unacceptable - unacceptable bid.

- 2) Bid by the bidder Aigo-BS d.o.o. Beograd (Knevinje Zorke 25-27, 11000 Beograd), bid number 3378 dated 29.02.2016.**

Committee notes that the bid has the following deficiency:

- offered technical specification does not fulfil the requests from the Bidding Document.

Offered price is: 109,400.00 € VAT excluded.

Considering that the estimated value for Lot 020 is 95,414.76 €, Committee notes that the offered price is higher than the estimated value, i.e. that the bid is financially unacceptable - unacceptable bid.

According to the aforementioned, Committee notes that the bid by the bidder Aiigo-BS d.o.o. Beograd is substantially not responsive - inadequate and financially unacceptable - unacceptable bid.

#### **LOT 021:**

- 1) Bid by the group of bidders Pan Computers d.o.o. (Puškinova 11, 21000 Novi Sad) i Ibis Instruments d.o.o. (Tošin bunar 272, 11070 Beograd), bid number 3411 dated 29.02.2016.**

Committee evaluated that the bid fulfils the requests from the Bidding Document, and it notes that the bid is substantially responsive - adequate bid.

Offered price is: 35,000.00 € VAT excluded.

Considering that the estimated value for Lot 021 is 35,000.00 €, Committee notes that the offered price is within the estimated value, i.e. that it is financially acceptable - acceptable bid.

According to the aforementioned, Committee notes that the bid by the group of bidders Pan Computers d.o.o. Beograd and Ibis Instruments d.o.o. Beograd substantially responsive - adequate and financially acceptable - acceptable bid.

- 2) Bid by the bidder Globe Corporation bv (Galvaniweg 4, 6101 XH ECHT, The Netherlands), bid number 3313 dated 26.02.2016.**

During the evaluation of the bids for lot 21, the Committee has determined that all the items which the bidder offered in Annex I – Technical Specification have not been clearly marked in the catalogue.

Section I – Instructions to bidders, clause 16. Documents Establishing the Eligibility and Conformity of the Goods and Related Services, in order to determine the conformity of the goods and the following services with the tender document, foresees that the bidder should submit, as the part of his bid, evidence that the goods are in conformity with the technical specification, in accordance with the Section VII - Schedule of Requirements. In Section VII - Schedule of Requirements, clause 2. Technical Specification (Annex I), the bidder who participates in the procurement procedure submits the filled form Annex I – Technical Specification and he is obliged to submit the catalogue, with the bid, in which he has to clearly mark, with the marker, the product (type/model) with all additional parts, which is being offered and also the lot and the item within the lot to which the bid refers have to be marked. Having this in mind, the Committee, on 16.05.2016., sent a clarification request (number 7514 dated 16.05.2016.), in which it requests for the bidder to submit the clarification of whether the equipment he offers contains all items requested in Annex I – Technical specification, which he offered in it, and he should have also stated where these items are in the catalogue which he submitted in the bid.

On 23.05.2016. the bidder submitted the clarification of the bid (number 7941 dated 23.05.2016.) in which he states that the equipment he offers contains all items requested in Annex I - Technical specification, and he submitted the complete list of these items.

According to the aforementioned, the Committee notes that the bid by the bidder KvarK d.o.o. Kragujevac is substantially not responsive - inadequate and financially unacceptable - unacceptable bid.

**1) Bid by the group of bidders Gosper d.o.o. Beograd and Vicor d.o.o. Beograd (Omladinskih brigada 86p, Beograd), bid number 3374 dated 29.02.2016.**

Committee evaluated that the bid fulfils the requests from the Bidding Document, and it notes that the bid is substantially responsive - adequate bid.

Offered price is: 123,000.00 € VAT excluded.

Considering that the estimated value for Lot 023 is 125,200.00 €, Committee notes that the offered price is lower than the estimated value, i.e. that it is financially acceptable - acceptable bid.

According to the aforementioned, Committee notes that the bid by the group of bidders Gosper d.o.o. Beograd and Vicor d.o.o. Beograd substantially responsive – adequate and financially acceptable - acceptable bid.

#### **LOT 024:**

Bidding Document foresees that the bidder proves the fulfilment of the conditions for Professional capacity by submitting the following evidence:

- Copies of signed contracts (or exceptionally, Copies of Invoices in question, and in that case the amount of the single invoice corresponds to a single contract),
  - List of references and
  - Confirmation Letter from Client.
- Having in mind that the requested professional capacity is undoubtedly proven by the bidder by submitting the other documents, the non-submission of Form EXP Experience is not considered to be a deficiency.

Committee notes that the bid has the following deficiency:

According to the aforementioned, the Committee notes that the bid by the bidder Globe Corporation bv, is substantially not responsive - inadequate and financially unacceptable - unacceptable bid.

##### **2) Bid by the bidder Engel d.o.o. za proizvodnju, trgovinu i usluge, Novi Sad (Novaka Radonjica 59, 21000 Novi Sad), bid number 3388 dated 29.02.2016.**

During the evaluation of the bid, Committee noted that the bidder, in accordance with the Section III – Evaluation and Qualification criteria, clause 2.3 Professional capacity of the bidder, sub-clause 2.3.1 Professional capacity, in the Form EXP Experience listed, among other things, the contract concluded with the Directorate of Measures and Precious Metals in the value of delivered goods of 338,900.00 euros in the period from 30.05.2012. until 07.06.2013 (contract number 393-1/0-01-78/12 dated 30.05.2012.). Attached to the form he also submitted the following documents:

- Contract on the public procurement concluded with the Directorate of Measures and Precious Metals, number 393-1/0-01-78/12 dated 30.05.2012. where the total contracted price including VAT is 44,510,692.20 dinars,
- Bid dated 17.04.2012. with the total offered price VAT excluded of 338,900.00 euros and

According to the aforementioned, the Committee notes that the bid by the bidder Kefo d.o.o. Beograd is substantially responsive - adequate and financially unacceptable - unacceptable bid.

**3) Bid by the group of bidders Bio-Logic Science Instruments d.o.o. (1. Rue de Europe F-38640 Claix France), bid number 2375 dated 17.02.2016.**

During the evaluation of the bid, the Committee determined that the bidder submitted Annex I – Technical specification unsigned and that the pages of the Form technical specification in which the data and changes are to be inserted, are not initialised by the person or persons authorized for signing the bid, which is foreseen in Section VII – Schedule of requirements, clause 2. Section I – Instructions to bidders, clause 16. Having this in mind, the Committee evaluates that the offered technical specification does not fulfil the requests from the Bidding Document.

Offered price is: 78,900.00 € VAT excluded.

Considering that the estimated value for Lot 032 is 40,000.00 €, Committee notes that the offered price is higher than the estimated value, i.e. that the bid is financially unacceptable - unacceptable bid.

According to the aforementioned, the Committee notes that the bid by the bidder Kvarak d.o.o. Kragujevac is substantially not responsive - inadequate and financially unacceptable - unacceptable bid.

#### **LOT 033:**

- 1) Bid by the bidder Superlab d.o.o. Beograd (Milutina Milankovića 25, 11000 Belgrade), bid number 3394 dated 29.02.2016.**

During the evaluation of the bid, the Committee determined that the bidder did not state the item "Motor rating input 15 W" in Annex I – Technical specification, and this item cannot be found in the submitted catalogue as well.

Section I – Instructions to bidders, clause 16. Documents Establishing the Eligibility and Conformity of the Goods and Related Services, in order to determine the conformity of goods and the related services with the bidding document, it is foreseen for the bidder to submit, as a part of his bid, evidence that the goods are in conformity with technical specification in accordance with the Section VII – Schedule of requirements, clause 2. Technical specification (Annex I), it is foreseen that the bidder, who participates in the procedure of the procurement, shall submit the filled form Annex I – Technical specification and that he is obliged to submit, with it, the catalogue in which he has to clearly mark the product (type/model) with a highlighter, with all its additional parts, which is being offered and also he has to mark the lot and the item within the lot to which the bid refers. Having this in mind the Committee, on 26.05.2016, sent a clarification request to the bidder (number 8185 dated 26.05.2016.) in which it requests the bidder to submit the clarification of whether the equipment offered by the bidder, includes the item "Motor rating input 15 W", as well as to state whether and where this item can be found in the catalogue which is submitted in the bid.

On 31.05.2016. the bidder submitted the clarification of the bid (number 8275 dated 31.05.2016.) in which he submitted the part of the catalogue where the requested item can be found. Considering that the bidder did not fully explain the bid in the requested part, on 03.06.2016., the Committee sent an additional clarification request (number 8400 dated 03.06.2016.) in which it requests the bidder to state precisely whether the equipment being offered includes the item "Motor rating input 15 W".

On 03.06.2016. the bidder submitted the explanation of the bid (number 8407 dated 03.06.2016.) in which he confirms that the equipment in lot 33 includes item "Motor rating input 15 W", which he documented with the instruction manual for this device, which was submitted in the previous clarification.

Committee evaluated that the bid fulfils the requests from the Bidding Document, and it notes that the bid is substantially responsive - adequate bid.

Offered price is: 2,778.00 € VAT excluded.

Considering that the estimated value for Lot 033 is 5,700.00 €, Committee notes that the offered price is lower than the estimated value, i.e. that it is financially acceptable – acceptable bid.

According to the aforementioned, the Committee notes that the bid by the bidder Superlab d.o.o. Beograd is substantially responsive – adequate and financially acceptable – acceptable bid.

**2) Bid by the bidder Kefo d.o.o. Beograd (Bačka IU, 11080 Belgrade), bid number 3352 dated 29.02.2016.**

Committee notes that the bid has the following deficiency:

- offered technical specification does not fulfil the requests from the Bidding Document.

Offered price is: 4,450.00 € VAT excluded.

Considering that the estimated value for Lot 033 is 5,700.00 €, Committee notes that the offered price is lower than the estimated value, i.e. that it is financially acceptable – acceptable bid.

According to the aforementioned, the Committee notes that the bid by the bidder Kefo d.o.o. Beograd is substantially not responsive – inadequate and financially acceptable – acceptable bid.

#### **LOT 034:**

##### **3) Bid by the bidder Globe Corporation bv (Galvaniweg 4, 6101 XH ECHT, The Netherlands), bid number 3320 dated 26.02.2016.**

Technical specification (Annex I), it is foreseen that the bidder, who participates in the procedure of the procurement, shall submit the filled form Annex I – Technical specification and that he is obliged to submit, with it, the catalogue in which he has to clearly mark the product (type/model) with a

According to the aforementioned, the Committee notes that the bid by the bidder Kefo d.o.o. Beograd is substantially not responsive - inadequate and financially acceptable - acceptable bid.

Committee evaluated that the bid fulfils the requests from the Bidding Document, and it notes that the bid is substantially responsive - adequate bid.

Offered price is: 25,394.00 € VAT excluded.

Considering that the estimated value for Lot 046 is 20,220.00 €, Committee notes that the offered price is higher than the estimated value, i.e. that the bid is financially unacceptable - unacceptable bid.

According to the aforementioned, the Committee notes that the bid by the bidder SC NOVAINTRMED is substantially responsive - adequate and financially unacceptable - unacceptable bid.

Committee notes that the bid has the following deficiencies:

- In accordance with Section VI Bank Policy - Corrupt and Fraudulent Practices, the bidder did not submit Covenant of Integrity to the Borrower from a Supplier;

- In accordance with Section X Contract forms, bidder did not submit the signed and verified by a stamp Model contract on the procurement of goods.

Offered price is: 165,000.00 € VAT excluded

Considering that the estimated value for Lot 047 is 165,000.00 €, Committee notes that the offered price is within the estimated value, i.e. that it is financially acceptable - acceptable bid.

According to the aforementioned, the Committee notes that the bid by the bidder Dex d.o.o. Beograd, is substantially not responsive - inadequate and financially acceptable - acceptable bid.

Committee evaluated that the bid fulfils the requests from the Bidding Document, and it notes that the bid is substantially responsive - adequate bid.

Offered price is: 98,000.00 € VAT excluded.

Considering that the estimated value for Lot 048 is 100,000.00 €, Committee notes that the offered price is lower than the estimated value, i.e. that it is financially acceptable - acceptable bid.

According to the aforementioned, the Committee notes that the bid by the bidder Uni-Chem d.o.o. is substantially responsive – adequate and financially acceptable - acceptable bid.

Upon the evaluation and overview of the bids, the Committee started ranking the substantially responsive – adequate and financially acceptable - acceptable bids based on the evaluation criterion.

The criterion for bid evaluation is the “**lowest offered price**”.

The bids are ranked from the lowest to the highest price. The lowest evaluated bid is the most favourable bid.

In case that there are two or more equal lowest evaluated bids, the Purchaser will choose a bid according to the following criteria:

- If there are two or more bids with the same offered price, bidder who offers shorter delivery period shall be considered more favourable;
- In case of two or more equal lowest evaluated bids, and Bidders offering the same delivery period – the most favourable bid shall be determined by a draw.


