(Official gazette of RS, No. 51/2010, 72/2013, 24/2014 and 65/2014) Acting Director of "JUP Istraživanje i razvoj" d.o.o. Beograd delivers

## DECISION ON CONTRACT AMENDMENT number 12574 dated 07.11.2016.

- 1. Contract is changed in clause 2. sub clause f) filled forms (including Price schedule with technical specification), concluded with the company IBIS-INSTRUMENTS d.o.o, Tošin bunar 272, New Belgrade, 11070 Belgrade, the Republic of Serbia, company registration number 17146165, TIN 100421862 (hereinafter: "Supplier"), filed at the Purchaser under number 12574 dated 14.10.2016. filed at the Supplier on 07.11.2016., under number 93-CON-SM-2016, after the conducted international open procurement procedure number IOP/9-2015/NCE/2 (hereinafter: Basic contract), where the Supplier is obliged at the position 35.1, within lot 035 EMF analysers and meters, at the unchanged contract price, instead of instrument 2245/30/FFT-32/E NARDA EFA-300, EFA-300 Electromagnetic Field Analyzers, by the manufacturer Willtron Technologies GmbH, to deliver the replacement instrument NBM-550 Broadband Field Meter NARDA with EHP-50F Field Analyzer NARDA.
- 2. Based on this Decision on contract amendment, Annex I of the Basic contract shall be created.
- 3. This Decision should be submitted to the other contract party within three days from the day of its delivery.

## Rationale

<u>Data on the Purchaser</u>: "JUP Istraživanje i razvoj" d.o.o. Beograd, with headquarters in Belgrade, Nemanjina 22-26, company registration number: 20668890, TIN: 106729004.

<u>Procurement procedure data</u>: procurement of goods, procurement number: IOP/9-2015/NCE/2 - Procurement of new capital equipment for the needs of scientific and research organizations, name from the general procurement vocabulary— various equipment, procurement mark: 39290000.

Upon the conducted procurement procedure number IOP/9-2015/NCE/2 - Procurement of new capital equipment for the needs of scientific and research organizations, for lot 35 - EMF Analyzers and meters, a contract is concluded with company IBIS-INSTRUMENTS d.o.o, Tošin bunar 272, New Belgrade, 11070 Belgrade, the Republic of Serbia, with contract price of 44,250.00 EUR VAT excluded.

During the realization of the Basic contract, the Supplier on 18.11.2016. informed the Purchaser, in writing, that the instrument at the position 35.1 - 2245/30/FFT-32/E NARDA EFA-300, EFA-300 Electromagnetic Field Analyzers, by the manufacturer

WiLLTRON Technologies GmbH, within lot 35 is no longer being produced and that a replacement instrument is offered.

Supplier submitted to the Purchaser the letter of the company WiLLTRON Technologies GmbH, the manufacturer of the mentioned device, which informs the Supplier that the manufacture of the contracted instrument has stopped and that the adequate replacement of the instrument is offered of the same manufacturer, so that instead of an instrument 2245/30/FFT-32/E NARDA EFA-300, EFA-300 Electromagnetic Field Analyzers, the instrument NBM-550 Broadband Field Meter NARDA with EHP-50F Field Analyzer NARDA as an adequate replacement is offered.

According to the aforementioned, the Supplier suggested to the Purchaser the delivery of the replacement instrument of the same manufacturer, so that instead of an instrument 2245/30/FFT-32/E NARDA EFA-300, EFA-300 Electromagnetic Field Analyzers, instrument NBM-550 Broadband Field Meter NARDA with EHP-50F Field Analyzer NARDA as an adequate replacement is offered, which fulfils all technical characteristics of the contracted instrument whose manufacture has stopped.

Supplier has obliged to deliver the offered replacement instrument at the same price which is contracted for instrument 2245/30/FFT-32/E NARDA EFA-300, EFA-300 Electromagnetic Field Analyzers at the position 35.1 of the manufacturer WiLLTRON Technologies GmbH, within lot 35, and in accordance with all other conditions of the Basic contract.

Having in mind the statements of the Supplier and the submitted evidence, and especially the fact that the cessation of the manufacture of the instrument in question represents the objective circumstance which the Supplier could not influence and due to which the Supplier is unable to deliver the contracted goods, therefore the Supplier offers the replacement for fulfilment and delivery of the instrument of the same manufacturer which fulfils all technical characteristics of the contracted instrument whose manufacture has stopped, it has been decided as in the enacting clause.

**Legal remedy:** It is not allowed to submit the complaint against this decision.
