Based on the requests for additional clarifications regarding tender dossier for procurement: Execution of works on the construction of residential buildings in Novi Sad, publication reference: RHP-W5-AB/IOP2-2017, we provide the following clarifications:

Question:

Please response to following requests for additional clarifications:

Under the **Human resources criteria**, subparagraph b), the Contracting Authority specified that in the month preceding the month of tender notice publication, all potential tenderers should demonstrate the employment of the occupational health and safety officer.

Please align this requirement with the Law on Safety and Health at Work in the Republic of Serbia, Article 37, "For the performance of occupational health and safety, an Employer may designate one or more of his employees or to engage a legal entity or entrepreneur who has a license..."

## Answer:

The Contracting Authority remains to the conditions from tender documentation, as it is in accordance with the provisions of the Law on Safety and Health at Work ("Official Journal of the Republic of Serbia" No. 101/2005, 91/2015 and 113/2017 - other law).

As foreseen in Article 37, paragraph 4 of the Law on Safety and Health at Work ("Official Journal of the Republic of Serbia" No. 101/2005, 91/2015 and 113/2017 - other law), for performing safety and health at work, an employer may designate one or more of his employees or to engage a legal entity or entrepreneur who has a license. The Contracting authority, in the respective procurement procedure, requires that a person for safety and health at work has to be employed by the Tenderer.

### **Question:**

(Filed under number: 904 dated 9th of February 2018)

Under the Financial capacity, subparagraph d), Available fund, the Contracting Authority specified that the Tenderer shall prove, by submitting relevant commercial bank statement, issued upon the publication of the Contract Procurement Notice, confirming that the tenderer has available or can dispose of liquid funds and/or credit line and/or other funds, in the amount of at least EUR 1.500.000,00 EUR.

Could you please confirm that condition will be accepted if we provide statements from several commercial banks that confirm that we have available funds, or that we have available liquid assets and / or credit line and / or other funds issued after the publication of the Contract Procurement Notice all in total 1.500.000,00 EUR.

# Answer:

The Tenderer can submit statements from several commercial banks that confirm that the Tenderer have available funds or that he can dispose with liquid assets and / or a credit line and / or other financial assets issued after the publication of the Contract Procurement Notice in the amount of at least 1,500,000, 00 EUR.

Procurement committee
