

CORRIGENDUM NO. 4 OF TENDER DOSSIER FOR THE PROCUREMENT OF: EXECUTION OF WORKS ON THE CONSTRUCTION OF RESIDENTIAL BUILDINGS, PUBLICATION REFERENCE: RHP-W5-AB/IOP1-2017

- There was an error in formating cells under the column "Price for unit without VAT" which is now corrected.
- 2. Mionica, Bill of quantities Position 12-03 under the Painting works Complete building and construction works:
- Under Position 12-03, a correction was made in the amount that represents the difference between Positions 12-01 and 12-02, and now it is 632.65 m2..

Financial offers of tendered whose technical offers were evaluated as unacceptable, shall not be opened and shall be returned to tenderers unopened."
