CORRIGENDUM no. 1.

TENDER DOCUMENTS FOR THE PROCUREMENT FOR CONSTRUCTION OF MULTI-FAMILY HOUSING WITHIN THE NINTH SUBPROJECT OF THE REGIONAL HOUSING PROGRAMME IN THE REPUBLIC OF SERBIA AT THE LOCATIONS:

NOVI SAD, VRBAS AND PANCEVO

In the procurement procedure number RHP-W9-AB-CW/IOP2-2020 whose subject is procurement for construction of multi-family housing within the ninth subproject of the Regional Housing Programme in the Republic of Serbia at the locations: Novi Sad, Vrbas and Pančevo, the Purchaser changes the Tender Documents, as follows:

Tender Documents - Instructions to tenderers, Contents (page 3.), the numbering of pages on which the items of the Tender Documents are, is amended.

Tender Documents - Instructions to tenderers, item 3 – Participation (right to participate), subitem 3.1 (page 5.) is amended, so that after sub-item 3.1.6, a sub-item 3.1.7. is added which now reads:

- " 3.1.7. Economic operator shall be excluded from the procurement procedure if:
- 3.1.7.1. in the period of previous three years, from the day of expiration of the tender submission deadline, it has not performed its obligations from the previously concluded procurement contracts or previously concluded concession agreement, the consequence of which has been a termination of that contract, collection of the security instruments, compensation for the damage etc.;
- 3.1.7.2. in the procurement procedures, in the previous three years, from the day of expiration of the tender submission deadline, it has submitted false data necessary for the verification of the grounds for exclusion or the criteria for the selection of the economic operator or has been unable to submit the evidence on fulfilment of criteria for the qualitative selection of the economic operator, if he used, as the means of proving, the Statement of compliance with mandatory requirement".

Tender Documents - Instructions to tenderers, item 3 - Participation (right to participate), paragraph 3.12, (page 6.) is amended so that it now reads:

"Tenderer registered in the Registry of tenderers, maintained by the Business Registers Agency, is not obligated to supply proofs referred to in subclasses 3.1.1. to 3.1.3".

Tender Documents - Instructions to tenderers, item 7, Tender Documents, Content of Tender Documents, Section 4, Tender form (page 8.), the sentence "Tenderer's statement on compliance with regulations (Form 4.6.8)" is deleted.

Tender Documents - Instructions to tenderers, item 12. Information/documents to be supplied by the tenderer, sub-item 12.1.7. line 5 (page 10.), is amended so that it now reads:

"Evidence of relevant experience in carrying out works of a similar nature, including the nature and value of the contracts, works in hand and contractually committed, which must contain references referred to in Form 4.6.4 of these Instructions. The tenderer must supply Form 4.6.4 for each member of the tenderer's joint venture/consortium".

Tender Documents - Instructions to tenderers, item 12, Information/documents to be supplied by the Tenderer, 12.1.All tenders must comprise the following information and duly completed documents, in sub-item 12.1.7. (page 12.) the sentence "Tenderer Statement on Compliance with Regulations (Form 4.6.8)" is deleted.

Tender Documents - Instructions to tenderers, item 12., Information/documents to be supplied by the tenderer (page 11.), sub-item 12.2. is amended so that it now reads:

"In order to be eligible for the award of the contract, tenderers must provide evidence that they meet the selection criteria. This must be provided by tenderers using the forms described in 12.1 above, with submission of the specified evidences, and any additional forms tenderers may wish to use."

Tender Documents – Volume 1, Section 2. Tender form, Form 1C.1 – Tenderer's statements of compliance with mandatory requirement (page 36), the following mandatory participation requirements are added so that they now read:

"That the economic operator, in the period of previous three years, from the day of expiration of the tender submission deadline, performed its obligations from the previously concluded procurement contracts or previously concluded concession agreement, that there have not been terminations of these contracts, collection of the security instruments, compensation for the damage etc. due to not performing its obligations;

That the economic operator, in the procurement procedures, in the previous three years, from the day of expiration of the tender submission deadline, has not submitted false data necessary for the verification of the grounds for exclusion or the criteria for the selection of the economic operator and that it has been able to submit the evidence on fulfilment of criteria for the qualitative selection of the economic operator, if he used, as the means of proving, the Statement of compliance with mandatory requirement".

Tender Documents – Volume 1, Section 2. Tender form, Form 1C.2 – Subcontractor's statements of compliance with mandatory requirement (page 38), the following mandatory participation requirements are added so that they now read:

"That the economic operator, in the period of previous three years, from the day of expiration of the tender submission deadline, performed its obligations from the previously concluded procurement contracts or previously concluded concession agreement, that there have not been terminations of these contracts, collection of the security instruments, compensation for the damage etc. due to not performing its obligations;

That the economic operator, in the procurement procedures, in the previous three years, from the day of expiration of the tender submission deadline, has not submitted false data necessary for the verification of the grounds for exclusion or the criteria for the selection of the economic operator and that it has been able to submit the evidence on fulfilment of criteria for the qualitative selection of the economic operator, if he used, as the means of proving, the Statement of compliance with mandatory requirement".

Tender Documents - Volume 1, Section 4. Tender form, Contents of the questionnaire, Form 4.6 - Professional and technical qualifications (**page 46.**), sentence "4.6.8 Tenderer's statement on compliance with regulations" is deleted.

Tender Documents - Volume 1, Section 4, Forms 4.6, Professional and technical qualifications (page 52.), the sentence "Forms 4.6.1. to 4.6.8 "is changed and reads" Forms 4.6.1. to 4.6.7".

Tender Documents - Instructions to tenderers, Volume 1, Professional and technical qualifications (page 68.), Form 4.6.8 - Tenderer's statement on compliance with regulations, is deleted.

In the remaining part, the Tender Documents remain unchanged.
