Regarding the requests for additional clarifications of the tender document for the procurement no. OP/R/01/15 - Performing construction, reconstruction and renovation works for the second group of schools within School Modernisation Programme – Component 3, we submit the following answers:

1. BIDDER'S QUESTION:

LOT 1 - SURDULICA-Elementary School J.J. Zmaj

SURDULICA - Elementary School J.J. Zmaj - B GYM VENTILATION AND AIR CONDITIONING, Item 1:

- a. Is one cooling fluid heat exchanger envisaged both for cooling and heating, or the heating should be controlled using a heat exchanger? Which cooling fluid is integrated in the system (R410A or R407)?
- b. Is the filtration envisaged within the air exhaust system?

ANSWER:

- a) In this stage compressor condensing unit is not foreseen.
- b) The chamber includes two filters, one filter class F5 and second filter class F8. Both are located in the supply section.

2. BIDDER'S QUESTION:

a. Which percentage of fresh air is required for the system to operate properly?

ANSWER:

Please find enclosed technical description (available only in Serbian).

4. BIDDER'S QUESTION:

LOT 4 - SEVOJNO

D. VENTILATION INSTALLATION, Item 1: 1:

a. How high is the required output temperature?

ANSWER:

Temperature is 38.6 C.

5. BIDDER'S QUESTION:

Will the Contracting authority accept as proof for the person for safety at work contract of engagement of a legal entity with a photocopy of the license for health and safety at work and a photocopy of the certificate of passed exam regarding practical training in performing of safety and health at work?

ANSWER:

The person responsible for health and safety at work can be engaged on any ground. In the Qualification Form 3.5.4 - Key Personnel, Bidder must state name and surname of person which will be responsible for health and safety at work.

In accordance with tender documentation it is necessary that the bidder submit resumes for all contractor representatives for the project management as well as Qualification Forms 3.5.4 and 3.5.4A

The Contracting Authority reserves the right to request from the bidders to additionally provide, for all technical staff hired at the project, the following documents:

- Copies of the requested licenses with the confirmation on the validity of licenses and certificate for a person employed for security and safety at work;
- Copies of certificates issued by contracting authorities or letter of recommendation or requested contracts which prove the professional experience.

6. BIDDER'S QUESTION:

Is it possible for the fulfilment of the mandatory requirements (certificate from the register of the competent authority, the competent courts certificates, certificate of the competent tax authority) to submit excerpt from the register of bidders issued by the Business Registers Agency of the Republic of Serbia which are regularly used in public procurement procedures?

ANSWER:

Please refer to Clarification no. 4 published on 19.02.2016. Answer no. 12.

7. BIDDER'S QUESTION:

In Part 2.2 - Tender data - clause 5.1 - the obligation to visit the sites.

Question: Is it necessary to announce site visits? If it is necessary, who should we send request to?

ANSWER:

It is not necessary to announce site visits.

8. BIDDER'S QUESTION:

Can the Bill of Quantities be filled and printed on computer or it must be written manually?

ANSWER:

Bill of Quantities does not need to be written manually.

9. BIDDER'S QUESTION:

In part 2.3 – Qualification Data - clause 2 - personnel capacity.

Question: Can the person for safety at work that has a license 410 and 411 meet the requirement regarding Civil Engineers where you require 4 people?

ANSWER:

In accordance with the tender documents requested personnel capacity in terms of the representative of the contractor for the management of the project amounts to a total of 12 people, of which the Bidder must have 4 Architect Engineer or Civil Engineer with licenses 400 or 401 or 402 or 410 or 411 and 1 person for safety at work.

10. BIDDER'S QUESTION:

In part 2.3 – Qualification Data - clause 2 - personnel capacity.

Question: Can same person be Project manager and one of 4 required executors - Civil Engineers?

ANSWER:

In accordance with the tender documents requested personnel capacity in terms of the representative of the contractor for the management of the project amounts to a total of 12 people, of which the Bidder must have 4 Architect Engineer or Civil Engineer with licenses 400 or 401 or 402 or 410 or 411 and 1 person as Project manager which can be Graduated Economist, Graduated Lawyer or Graduated Engineer.

11. BIDDER'S QUESTION:

In part 2.3 – Qualification Data - clause 2 - personnel capacity.

Question: Can the decision on appointment of responsible contractor be used as evidence of professional experience for the engineering staff?

ANSWER:

In accordance with tender documents, it is necessary that the bidder submit resumes for all contractor representatives for the project management and Qualification Forms 3.5.4 and 3.5.4A.

The Contracting Authority reserves the right to request from the bidders to additionally provide, for all technical staff hired at the project, the following documents:

- Copies of the requested licenses with the confirmation on the validity of licenses and certificate for a person employed for security and safety at work;
- Copies of certificates issued by contracting authorities or letter of recommendation or requested contracts which prove the professional experience.
