Regarding the requests for additional clarifications of the tender document for the procurement no. OP/R/01/15 - Performing construction, reconstruction and renovation works for the second group of schools within School Modernisation Programme – Component 3, we submit the following answers:

1. BIDDER'S QUESTION:

Do the Letters of Intent need to be in EUR?

ANSWER:

Since the value of the bid is expressed in EUR, it is necessary that a bank guarantee and requested letters of intent are expressed in EUR.

2. BIDDER'S QUESTION:

Within the 2.3 Qualification data in the part: Additional requirements for participation in the tender procedure, under item 1. Financial and economic capacity that refers to average annual operating income from construction activities (works on construction, reconstruction, upgrading, adaptation or rehabilitation of buildings) for the last 3 (three) years (2012, 2013, 2014) it is stated to submit qualifications forms 3.5.1 and 3.5.2 as the evidence in which data regarding contracts for the construction works carried out in 2012, 2013 and 2014 should be inserted.

It is unclear whether the value of construction works completed in 2012 on the basis of contracts signed in 2011 is considered as average annual operating income for the year 2012? Within Clarifications No. 5 from 22.02.2016 bidder's question, number 2 you answered that as general information about the experience you are accepting business income from 2015. In this regard, do you accept contracts that are executed during 2015 and cited as evidence of experience as the average annual operating income from construction activity, which is required under Section 1.a.?

ANSWER:

Value of construction works completed in 2012 on the basis of contracts signed in 2011 and the value of the works executed during 2015 will be considered as the business income.
