Based on the requests for additional clarifications regarding tender dossier for procurement: Execution of works on the construction of residential buildings, publication reference: **RHP-W5-AB/IOP2-2017**, we provide the following clarifications:

Please response to following requests for additional clarifications:

In Bill of quantities of residential building in Veternik, block 1,2 and 3, position 02-05 – Supply of material, transport and covering of flat passable roofs (load bearing system), is given the same description as position 02-04 – Supply of material, transport covering of flat roofs.

Please take into consideration that other materials, must be used for the surface of passable roofs:

Thermal insulation with closed cell structure eg. PIR or XPS, waterproofing must be of the type Sikaplan U 15 or similar, which means that the roof surface membrane is intended for the ballast area, and it is also UV stable for non-covering surfaces, around waterproofing in two layers (depending on the type of thermal insulation) a separating layer of the geotextile type of minimum 300 g/m² is used, as well as a protective PE foil before making the liner.
