

**CORRIGENDUM NO. 1 OF TENDER DOSSIER FOR THE PROCUREMENT OF:
EXECUTION OF WORKS ON THE CONSTRUCTION OF RESIDENTIAL
BUILDINGS, PUBLICATION REFERENCE: RHP-W5-AB/IOP4-2017**

Tender dossier for the procurement of: Execution of works on the construction of residential buildings, publication reference: RHP-W5-AB/IOP4-2017, is being modified as follows:

1. On page 1. of Tender notice, under the item 8. Description of the subject of the procurement, paragraph 3, that reads:

„The scope of this project implies the execution of works on the construction of residential buildings intended for social housing: Valjevo - 20 apartments, Užice - 10 apartments, Čajetina - 12 apartments, Novi Pazar - 20 apartments, Kikinda – 16 apartments, Bački Petrovac - 3 apartments, Bačka Palanka - 16 apartments, Irig - 12 apartments, Sremski Karlovci - 16 apartments, Pančevo - 8 apartments.“

Is being modified as follows:

„The scope of this project implies the execution of works on the construction of residential buildings intended for social housing: Valjevo - 20 apartments, Užice - 10 apartments, Čajetina - 12 apartments, Novi Pazar - 20 apartments, Kikinda – 16 apartments, Bački Petrovac - 3 apartments, Bačka Palanka - 16 apartments, Irig - 13 apartments, Sremski Karlovci - 16 apartments, Pančevo - 8 apartments.“

2. On page 2. of Tender notice, under the item 9. Number of lots, if procurement is divided in lots, that reads:

„4 Lots:

- Partija 1: Valjevo (20), Užice (10), Čajetina (12) – 42 apartments;
- Partija 2: – Novi Pazar - 20 apartments;
- Partija 3: Kikinda (16), Bački Petrovac (3), Bačka Palanka (16) – 35 apartments;
- Partija 4: Irig (12) Sremski Karlovci (16), Pančevo (8)– 36 apartments“.

Is being modified as follows:

„„4 Lots:

- Partija 1: Valjevo (20), Užice (10), Čajetina (12) – 42 apartments;

- Partija 2: – Novi Pazar - 20 apartments;
 - Partija 3: Kikinda (16), Bački Petrovac (3), Bačka Palanka (16) – 35 apartments;
 - Partija 4: Irig (13) Sremski Karlovci (16), Pančevo (8)– 37 apartments“.
3. On page 10 of Volume 1, Section 1 – Instructions to tenderers, under the item **11.2** that reads:

„The works are divided into 4 (four) lots:

- Partija 1: Valjevo (20), Užice (10), Čajetina (12) – 42 apartments;
- Partija 2: – Novi Pazar - 20 apartments;
- Partija 3: Kikinda (16), Bački Petrovac (3), Bačka Palanka (16) – 35 apartments;
- Partija 4: Irig (12), Sremski Karlovci (16), Pančevo (8)– 36 apartments;“

Is being modified as follows:

„The works are divided into 4 (four) lots:

- Partija 1: Valjevo (20), Užice (10), Čajetina (12) – 42 apartments;
- Partija 2: – Novi Pazar - 20 apartments;
- Partija 3: Kikinda (16), Bački Petrovac (3), Bačka Palanka (16) – 35 apartments;
- Partija 4: Irig (13), Sremski Karlovci (16), Pančevo (8)– 37 apartments;“

All other terms and conditions of the Tender Dossier remain unchanged.

The above mentioned modifications form an integral part of the Tender dossier.
