2. Programme and financing: *Joint regional programme on permanent solutions for refugees and displaced people (Regional Housing Programme – RHP/ Housing Programme in the Republic of Serbia)*
Framework Agreement concluded between the Council of Europe Development Bank and the Republic of Serbia regarding the Regional Housing Programme, signed on 25th October 2013 and Grant Agreement concluded between the Council of Europe Development Bank and the Republic of Serbia regarding the realization of the third sub-project of Regional Housing Programme, signed on 9 September 2014.

8. Procurement of building material, code from ORN: 44110000.

In the Agreement on implementation of the Country Housing Programme in the Republic of Serbia, the provision of packages of building material is foreseen as one of modalities, (B: Building material).

The mentioned modality of housing programme is defined as providing support to the integration of refugees who have already started building the houses or who possess inadequate houses suitable for adaptation, through provision of packages of building material.

The scope of this project implies **the delivery of 141 packages of building material** to the beneficiaries, on locations given in Annex 2: Bill of Quantities, of this tender dossier.

9. Number of lots provided that the contract is divided into lots:

Procurement is divided into 7 Lots (eight):

- **Lot 1** – Barajevo – 20 packages of building material;
- **Lot 2** - Barajevo – 20 packages of building material;
- **Lot 3** – Barajevo (2), Lazarevac (5), Obrenovac (13) – 20 packages of building material;
- **Lot 4** – Obrenovac (5), Čukarica (16) – 21 packages of building material;
- **Lot 5** - Sopot – 20 packages of building material;
- **Lot 6** – Sopot (3), Grocka (17) – 20 packages of building material;
- **Lot 7** – Grocka (9), Rakovica (6), Mladenovac (5) – 20 packages of building material.

10. Total estimated value of procurement, estimated value per lot:

Total estimated value of procurement is: 1.040.400,22 euro VAT excluded.

12. Qualification criteria:

All interested people who act individually or as a part of a group and who fulfil the criteria for participation defined in the Tender Documents part: Instruction to tenderers for building material contract award, Section 3: Qualification criteria (Right to participate), as well as the conditions defined in the Guidelines for procurement of supplies, works and services of Council of Europe Development bank; Section 3.3: Eligibility to participate in tenders and provide supplies, works and services have the right to participate.

13. Selection criteria:

Tenderers are obliged to fulfil the following conditions:

1. Financial capacity of the Tenderers:

- a) **Liquidity:** The Tenderer must not have had any registered blockage of their account in the twelve (12) months preceding the day of publishing the Procurement Notice.

Joint Venture/Consortium: This criterion will be applied to each member of the Joint Venture/Consortium.

Tenderer/Subcontractor: This criterion will be applied to each Subcontractor.

- b) **Bankruptcy and liquidation:** Tenderer is not in the proceedings of bankruptcy or liquidation, i.e. the previous bankruptcy proceedings.

Joint Venture/Consortium: This criterion will be applied to each member of the Joint Venture/Consortium.

Tenderer/Subcontractor: This criterion will be applied to each Subcontractor.

- c) **Business revenue:** Tenderer must have an total business revenue, during the previous three years (2015, 2016 and 2017), not less than:

- **For Lot 1:** 220.000,00 euro;
- **For Lot 2:** 200.000,00 euro;
- **For Lot 3:** 220.000,00 euro;
- **For Lot 4:** 240.000,00 euro;
- **For Lot 5:** 230.000,00 euro;
- **For Lot 6:** 250.000,00 euro;
- **For Lot 7:** 230.000,00 euro.

in euro at the middle exchange rate of the National bank of Serbia at the end of the report period.

If the Tenderer submits the tender for two or more Lots, it then must have total business revenue, which is not less than **the sum of the above stated amounts for the lots for which the tender is submitted.**

Joint Venture/Consortium: This criterion will be applied to the Joint Venture/Consortium as a whole.

2. Business capacity of the Tender:

- a) **Tenderers experience.** The Tenderer must prove that, in the period from 01.01.2015. until the publication of the Contract Procurement Notice, made income from the sale of building material in the value of at least:

- **For Lot 1:** 150.000,00 euro;
- **For Lot 2:** 130.000,00 euro;

- For Lot 3: 150.000,00 euro;
- For Lot 4: 160.000,00 euro;
- For Lot 5: 150.000,00 euro;
- For Lot 6: 160.000,00 euro;
- For Lot 7: 150.000,00 euro.

at the middle exchange rate of the National bank of Serbia at the end of the reporting period, except for the income from the sale in 2018, the value of which will be calculated at the middle exchange rate of the National bank of Serbia on the day of the publication of the Contract Procurement Notice.

If the Tenderer submits a tender for two or more lots, the Tenderer must prove that he made income from the sale of building material in the value of at least **the sum of minimum required values for the lots for which he submits the tender.**

Joint Venture/Consortium: This criterion will be applied to the Joint Venture/Consortium as a whole.

b) ISO 9001:2015

Joint Venture/Consortium: This criterion shall be fulfilled by any member of Joint Venture/Consortium - at least one member.

Lowest offered price.

The Contracting Authority shall open the tenders publically and it can be attended by any interested person, at the time and place stated in the Contract Procurement Notice and in the Instructions to Tenderers for building material contract award. Only authorized representatives of the Tenderers' can actively participate in the tender opening session, and they are obliged to submit the authorization for attending and signing, as well as to sign the document which confirms their presence.

19. Deadline for making the Decision on contract award: No later than 60 days from the day of tender submission deadline.
