Since the estimated value of the procurement for Lot 1 is 223.600,00 EUR VAT excluded, the Committee notes that the value of the Bid by the Bidder Consortium: DOO GRAĐING ALEKSANDROVAC, MILOSEVIĆ DOO KRUŠEVAC and MODUL-INŽINJERING DOO KRUŠEVAC, Bid no. 11/2019 dated 14.01.2019, is higher than the estimated value of the procurement for Lot 1.

Committee checked for calculation errors in the Bid and noted that there are no calculation errors.

According to the aforementioned the Committee notes that the Bid by the Bidder Consortium: DOO GRAĐING ALEKSANDROVAC, MILOSEVIĆ DOO KRUŠEVAC and MODUL-INŽINJERING DOO KRUŠEVAC, Bid no. 11/2019 dated 14.01.2019, is acceptable, however it is higher than the estimated value for Lot 1.

Offered price is: 252.776, 62 EUR VAT excluded

Since the estimated value of the procurement for Lot 1 is 223.600,00 EUR VAT excluded, the Committee notes that the value of the Bid by the Bidder JADRAN DOO BEOGRAD, bid no. 05/19 dated 15.01.2019, is higher than the estimated value of the procurement for Lot 1.

During the evaluation of the bids, the Committee checked for calculation errors and noted that in the Bid by the Bidder JADRAN DOO BEOGRAD, Bid no. 05/19 dated 15.01.2019, there are calculation errors:
