

CORRIGENDUM no.1.

OF THE TENDER DOCUMENTS FOR THE PROCUREMENT OF FURNITURE AND EQUIPMENT FOR THE SECOND GROUP OF SCHOOLS WITHIN "SCHOOL MODERNISATION PROGRAMME"

For the procurement procedure no. OP/D/01/19, the subject of which is Procurement of furniture and equipment for the second group of schools within School Modernisation Programme, the Purchaser changes the Tender Documents as follows:

- 1. In parts Technical Specification and Price Schedule LOT 1 the following is changed:
- Item 1.19 "Teacher's desk with equipment and power distribution cabinet, for physics cabinet, Const.: Metal / refined chipboard, dim.: 230x70x70 cm" is erased.
- 2. In parts Technical Specification and Price Schedule LOT 3 the following is changed:
- Item 1.13 "Freezer, capacity 530 l, (stainless steel AISI 304 18/10), dim. 130x86x210 cm" now reads "Freezer, capacity 530 l, (stainless steel AISI 304 18/10)".
- Item 1.22 "PLATES (shallow, deep and dessert) set" now reads: "Plate set, metal (Set consists of one shallow, one deep and one dessert plate)".
- Item 1.23 "Cutlery (knife, fork, spoon, teaspoon) set metal" now reads "Set of cutlery, metal (Set consists of one knife, one fork, one spoon and one teaspoon)".
- Item 1.24 "Kitchen Standard 220, Material refined plywood 18mm, Width, Depth 60cm, Height 222 cm" now reads: "Kitchen, material refined plywood 18mm. Length 220, Depth 60cm, Height 222cm".
- Item 1.31 "Hanging wall cabinet, with plate drainer, (INOX AISI 304 18/10), dim. 130x40x70 cm" now reads "Hanging wall cabinet, with plate drainer (stainless steel drainer AISI 304 18/10), di. 130 * 40 * 70cm"
- Item 1.37 "Hanging cupboard, dim.:80x72x31 cm" now reads "Hanging cupboard, dim.:80x72x31 cm, refined plywood"
- Item 1.38 "Hanging cupboard, dim.: 40x72x31 cm" now reads "Hanging cupboard, dim.: 40x72x31 cm, refined plywood"

Item 1.38a "Hanging cupboard, two-door, 80х40х50см" now reads "Hanging cupboard, two-door, 80х40х50см, refined plywood"

Item 1.38 b "Hanging cupboard, two-door, 40x60x40cm" now reads "Hanging cupboard, two-door, 40x60x40cm, refined plywood"

Item 1.39 "Element with drawers, 40x85x60 cm" now reads "Element with drawers, 40x85x60 cm, refined plywood"

Item 1.40 "Kitchen work station, 40x85x60 cm" now reads "Kitchen work station, 40x85x60 cm, refined plywood"

Item 1.40a "Kitchen work station, 80x40x80cm" now reads "Kitchen work station, 80x40x80cm, refined plywood"

Item 1 .40 b "Kitchen work station, with shelves and drawers 400x60x60 cm" now reads "Kitchen work station, with shelves and drawers 400x60x60 cm, refined plywood"

Item 1.41 "Service trolley" now reads "Serving trolley (two-level or three-level)".

In the remaining part, the Tender Documents remain unchanged.
