

**CLARIFICATION no. 5**  
**OF THE TENDER DOCUMENTS FOR THE PROCUREMENT OF FURNITURE**  
**AND EQUIPMENT FOR THE SECOND GROUP OF SCHOOLS WITHIN SCHOOL**  
**MODERNISATION PROGRAMME**

**Public reference: OP/D/01/19**

Regarding the requests for clarification for the procurement of: **Furniture and equipment for the second group of schools within School Modernisation Programme**, procurement number **OP/D/01/19**, we deliver the following answers:

**Question no. 1:**

(filed under number 7591 dated 16.12.2020.)

Within the Tender forms there is the form Bid security stating:

„We have been informed that [name of the Bidder] (hereinafter called "the Bidder") has submitted to you its bid no. [number of the Bid] dated [date of the Bid] (hereinafter called "the Bid") for the execution of [name of contract] under Invitation for Bids No. [IFB number] ("the IFB")."

Since we need the Bank security in order to submit the bid, it is not possible to insert the number and date of the bid, since it shall be just submitted, because in the moment of security issuing we still do not have the bid submitted. Is the security valid if it does not contain the number and date of the bid, and the text of the security is identical as in the form?

**Answer:**

It is not necessary for the text of the guarantee to contain the number and date of the bid, provided it contains all other elements foreseen by the form from the Tender Document.

**Question no. 2:**

Technical Specification, description of item 1.24 – School chair the following is written:

Construction: metal pipes min. dimensions 20/20mm, 2 mm wall thick. Epoxy colour RAL 9006.

Protection pads.

Seat w/l=37/39cm, back w/l=43/22cm

Seat and back: beech laminated plywood, ergonomic, 8mm thick.

We think this is probably a technical error because there is a great difference between the width of the seat and the width of the backrest. They should be of the same width.

Technical Specification, description of item 1.28 – Upholstered work chair

Backrest upholstered default profile dimensions 33cmx14cm, the seat of the default profile, padded, size 30x31cm. Frame from metal pipes min. dimensions 20/20mm, 2 mm wall thick. Epoxy colour RAL 9006. Protection pads. Seat and backrest: beech veneer, upholstered in fabric.

We think this is probably a technical error because there is a great difference between the width of the seat and the width of the backrest, and these seat dimensions of 30x31cm are intended for preschool age.

Item 1.22 - is it important only to have the set of plates made of stainless steel or is there a requested diameter?

Item 1.39 you entered an element with drawers, which element you imply? Lower, upper or...

Page 34 of the tender Document C. Bid preparation under clause ITB 11.1(x) the following is written:

The Bidder shall submit the following additional documents in its bid:

- Covenant of Integrity
- Environmental and Social Covenant
- All other additional documents ...

Is the Covenant of Integrity, a Statement on independent bid?

What is implied under Environmental and Social Covenant?

**Answer:**

Covenant of Integrity and Environmental and Social Covenant are separate forms contained in the Tender Document.

The content of the mentioned forms is foreseen in the Tender Document.

**Question no. 23:**

(filed under number 7684 dated 18.12.2020.)

Should the reference certificates be in free form and is the amount on the certificate the amount of the contract VAT included?

**Answer:**

Tender Document foresees that, as one of the evidence on fulfilment of additional condition under b) Business capability, the bidder submits the Investor certificates on form - Investor certificate, which is a part of the Tender Document. Bidder can submit the Investor certificate in some other form as well, provided that it contains all data foreseen by the mentioned form of the Tender Document. Value of the referent deliveries shall be expressed in EUR Vat excluded.

**Question no. 24:**

For items 1.47., 1.48. and 1.49 you gave the codes M-107 of the former manufacturer RAD a.d. – Beograd. On the market today, there are no goods with such marks. Please define more precisely the requested positions.
